



NY-601 - Poughkeepsie/Dutchess County CoC

1/1/2017-3/31/2017

Overview - All Programs

Between 1/1/2017 and 3/31/2017, providers in the Poughkeepsie/Dutchess County CoC served 994 people experiencing or at risk of experiencing homelessnessⁱ. Residential programs served 874 people, and 167 people were served by supportive services only programsⁱⁱ.




There were 781 households in the CoC, including: 662 households without children (containing 679 individuals), 92 households with both adults and children (containing 109 adults and 176 children), and 27 households of only unaccompanied minors (under 18 years of age), containing 30 minorsⁱⁱⁱ.

By gender, providers in the CoC served 430 (43.3%) women, 563 (56.6%) men and 1 (0.1%) trans-identified individuals.


The racial and ethnic breakdown of those served included: 456 (45.9%) White, 478

(48.1%) Black or African-American, 2 (0.2%) Asian, 1 (0.1%) Native Hawaiian or Other Pacific Islander, 4 (0.4%) American Indian or Alaskan Native, and 51 (5.1%) Multiple Races. 148 (14.9%) individuals identified as Hispanic/Latino regardless of race.




Out of 810 adults or heads of household, 302 (37.3%) indicated a prior residence of Emergency Shelter, the streets, or Safe Haven. Of these clients, 165 (20.4%) reported no previous episodes of homelessness within the last three years. 71 (8.8%), 30 (3.7%), and 38 (4.7%) reported that they had been homeless 2, 3, or 4+ times (respectively) during the same time frame. 5 (0.6%) did not report on this data element.

For the adults or heads of household who were in program a year or more and received an annual assessment (90), 27 (30.0%) saw an increase in income (cash and cash benefits) between admission and the most recent update, while 48 (53.3%) saw no change in income that was initially higher than zero^{iv}.



The total number of individuals discharged during the quarter was 281, which included 225 adults and 56 children. 91 (32.4%) were discharged to a permanent destination. Income for 20 (8.9%) clients over 18 rose between admission and discharge, while 187 (83.1%) maintained stable income of greater than zero.

Special Needs – HUD and HHS Funded Programs Only



64.2% of adults (405/631) and 21.0% of children (29/138) in HUD or HHS funded programs self-reported at least one physical, emotional, or other health condition regardless of whether condition become serious enough to be disabling. Among those reporting

multiple conditions, the most significant comorbidity was Mental Health and Substance Use (159). When taking severity of condition into account, 316 adults reported conditions that met the criteria to be considered a disability.

Sub-Populations – *All Programs*

47 (7.4%) individuals over 18 met the criteria for chronic homelessness at the time of project entry. ¹ 1 out of every 7.8 adults receiving services this quarter was a veteran (12.8%). Out of the 81 veterans served, 33 (40.7%) reported a disabling condition and 6 (7.4%) met the criteria for chronic homelessness at admission.

Data quality and completeness play a major role in ensuring that the System Performance Measures accurately reflect the work being done within the CoC. CARES routinely tracks the health of HMIS data and this information may be found at www.caresny.org.
