



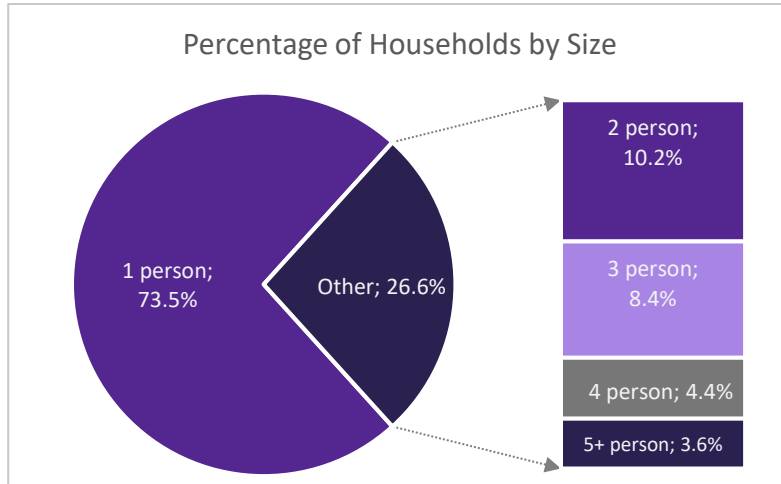
## Quarterly Report

### NY-608 - Kingston/Ulster County CoC

1/1/2017-3/31/2017

#### Overview – All Programs

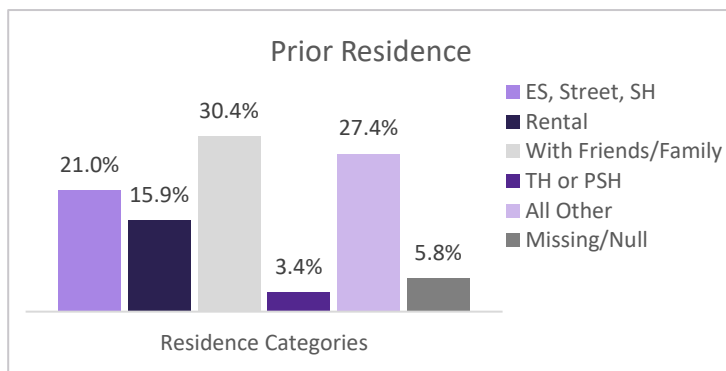
Between 1/1/2017 and 3/31/2017, providers in the Kingston/Ulster County CoC served 787 people experiencing or at risk of experiencing homelessness<sup>i</sup>. Residential programs served these 787 individuals<sup>ii</sup>.



There were 501 households in the CoC, including: 334 households without children (containing 337 individuals), 129 households with both adults and children (containing 160 adults and 251 children), and 38 households of only unaccompanied minors (under 18 years of age), containing 39 minors<sup>iii</sup>.

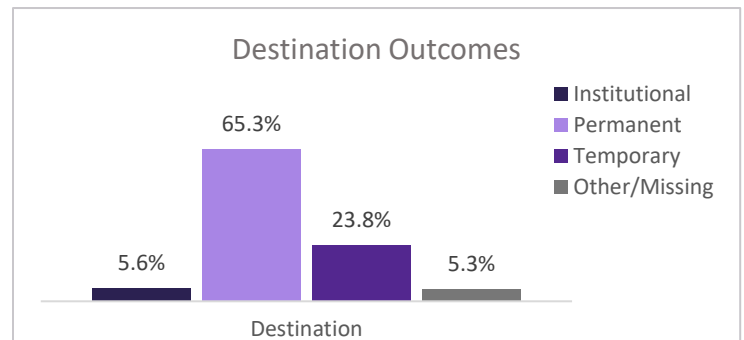
By gender, providers in the CoC served 390 (49.6%) women, 395 (50.2%) men and 2 (0.3%) trans-identified individuals.

The racial and ethnic breakdown of those served included 487 (61.9%) White, 234 (29.7%) Black or African-American, 3 (0.4%) Asian, 3 (0.4%) Native Hawaiian or Other Pacific Islander, 3 (0.4%) American Indian or Alaskan Native, and 49 (6.2%) Multiple Races. 120 (15.2%) individuals identified as Hispanic/Latino regardless of race.



Out of 533 adults or heads of household, 112 (21.0%) indicated a prior residence of Emergency Shelter, the streets, or Safe Haven. Of these clients, 53 (9.9%) reported no previous episodes of homelessness within the last three years. 31 (5.8%), 10 (1.9%), and 19 (3.6%) reported that they had been homeless 2, 3, or 4+ times (respectively) during the same time frame. 1 (0.2%) did not report on this data element.

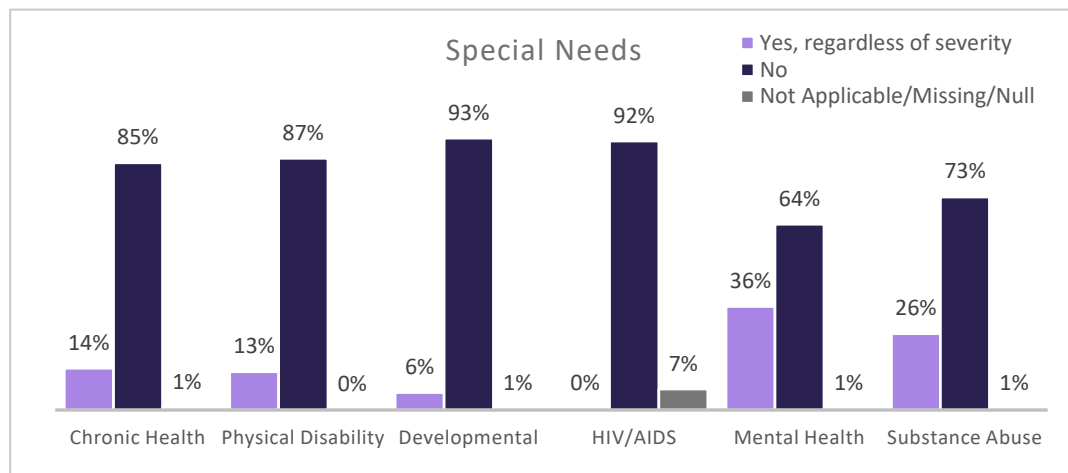
For the adults or heads of household who were in program a year or more and received an annual assessment (35), 11 (31.4%) saw an increase in income (cash and cash benefits) between admission and the most recent update, while 16 (45.7%) saw no change in income that was initially higher than zero<sup>iv</sup>.



The total number of individuals discharged during the quarter was 378, which included 244 adults and 134 children. 247 (65.3%) were discharged to a

permanent destination. Income for 36 (14.8%) clients over 18 rose between admission and discharge, while 202 (82.8%) maintained stable income of greater than zero.

### **Special Needs – HUD and HHS Funded Programs Only**



72.2% of adults (359/497) and 13.1% of children (38/290) in HUD or HHS funded programs self-reported at least one physical, emotional, or other health condition *regardless of whether the condition had become serious enough to be disabling*. Among those reporting

multiple conditions, the most significant comorbidity was Mental Health and Substance Use (134). When taking severity of condition into account, 305 adults reported conditions that met the criteria to be considered a disability.

### **Sub-Populations – All Programs**

18 (3.6%) individuals over 18 met the criteria for chronic homelessness at the time of project entry.<sup>v</sup> 1 out of every 38 adults receiving services this quarter was a veteran (2.6%). Out of the 13 veterans served, 9 (69.2%) reported a disabling condition and none met the criteria for chronic homelessness at admission.
