

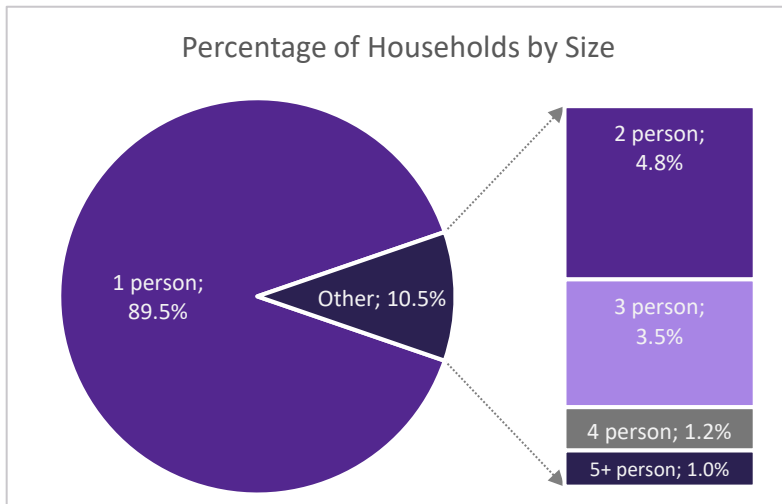
Quarterly Report

NY-602 - Newburgh/Middletown/Orange County CoC

4/1/2017-6/30/2017

Overview – All Programs

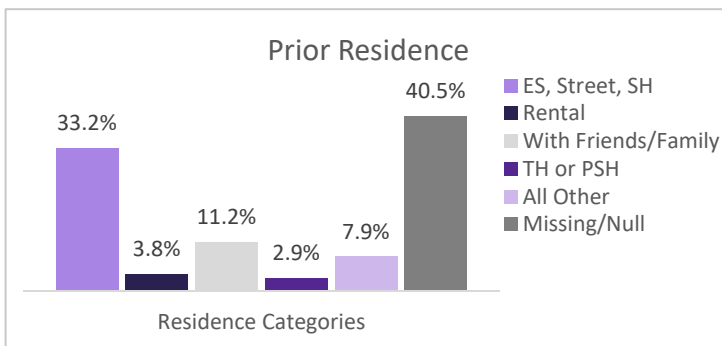
Between 4/1/2017 and 6/30/2017, providers in the Newburgh/Middletown/Orange County CoC served 1488 people experiencing or at risk of experiencing homelessnessⁱ. Residential programs served 838 peopleⁱⁱ, and supportive services only (SSO) programs served 654 peopleⁱⁱⁱ.



There were 1242 households in the CoC, including: 893 households without children (containing 902 individuals), 119 households with both adults and children (containing 147 adults and 204 children), and 230 households of only unaccompanied minors (under 18 years of age), containing 235 minors^{iv}.

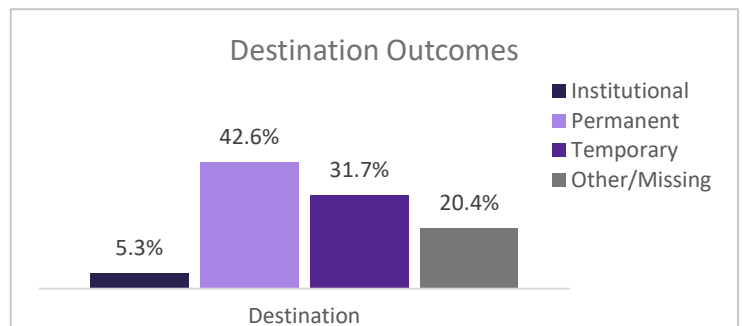
By gender, providers in the CoC served 673 (45.2%) women, 771 (51.8%) men, and 2 (0.1%) trans-identified individuals.

The racial and ethnic breakdown of those served included: 710 (47.7%) White, 477 (32.1%) Black or African-American, 6 (0.4%) Asian, 13 (0.9%) Native Hawaiian or Other Pacific Islander, 14 (0.9%) American Indian or Alaskan Native, and 187 (12.6%) Multiple Races. 301 (20.2%) individuals identified as Hispanic/Latino regardless of race.



Of 1273 adults or heads of household, 422 (33.2%) indicated a prior residence of Emergency Shelter, the streets, or Safe Haven. Of these clients, 149 (35.3%) reported no previous episodes of homelessness within the last three years. 52 (12.3%), 42 (10.0%), and 58 (13.7%) reported that they had been 2, 3, or 4+ times homeless (respectively) during the same time frame. 121 (28.7%) did not report on this data element.

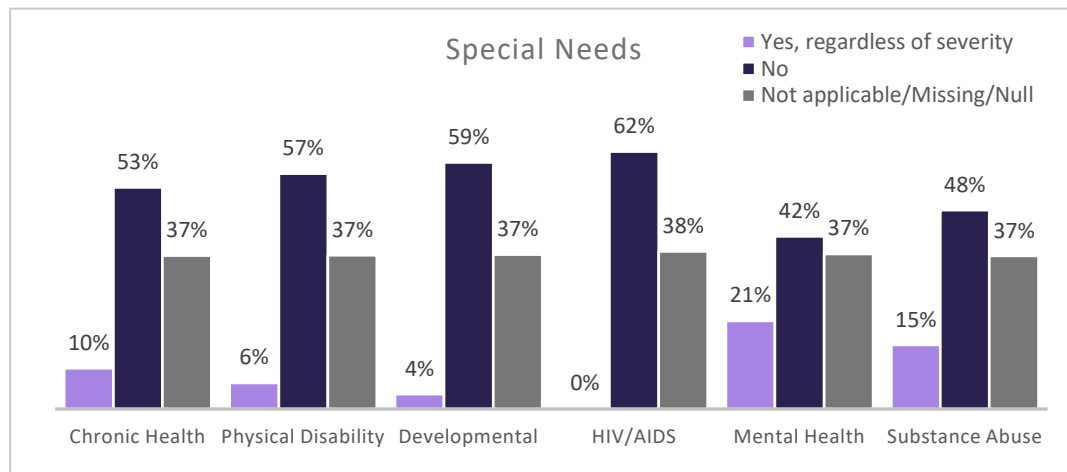
For the adults or heads of household who were in program a year or more and received an annual assessment (125), 61 (48.8%) saw an increase in income (cash and cash benefits) between admission and the most recent update, while 43 (34.4%) saw no change in income that was initially higher than zero^v.



The total number of individuals discharged during the quarter was 284, which included 187 adults and 97 children. 121 (42.6%) were discharged to a permanent

destination. Income for 30 (16.0%) clients over 18 rose between admission and discharge, while 134 (71.7%) maintained stable income of greater than zero.

Special Needs – HUD and HHS Funded Programs Only



46.7% of adults (400/856) and 8.0% of children (30/375) in HUD or HHS funded programs self-reported at least one physical, emotional, or other health condition *regardless of whether the condition had become serious enough to be disabling*. Among those reporting

multiple conditions, the most significant comorbidity was Mental Health and Substance Use (86). When taking severity of condition into account, 249 adults reported conditions that met the criteria to be considered a disability.

Sub-Populations – All Programs

53 (6.2%) individuals over 18 met the criteria for chronic homelessness at the time of project entry.^{vi} 1 out of every 14.5 adults receiving services this quarter was a veteran (6.9%). Out of the 59 veterans served, 32 (54.2%) reported a disabling condition and 10 (16.9%) met the criteria for chronic homelessness at admission.
