



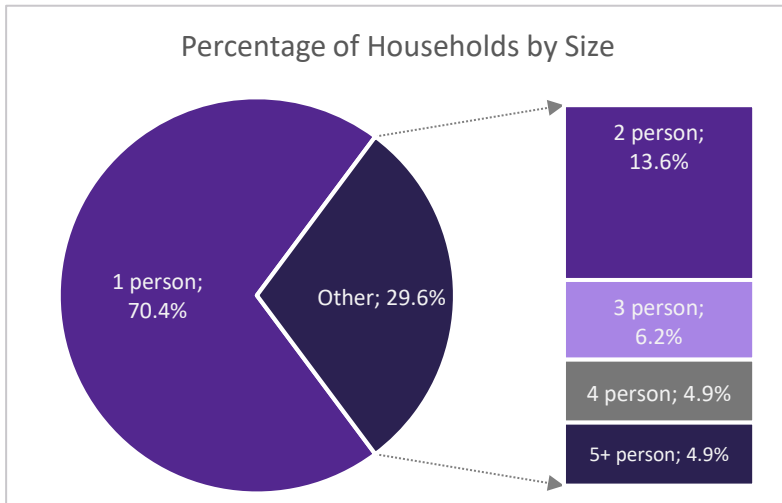

Overview – All Programs

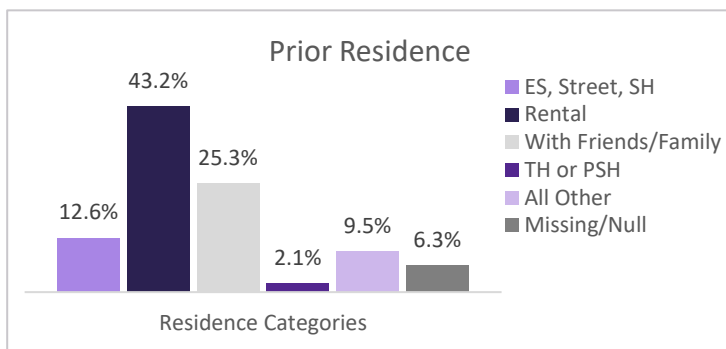
Between 7/1/2017 and 9/30/2017, providers in the Fulton/Montgomery/Schoharie Counties CoC served 137 people experiencing or at risk of experiencing homelessnessⁱ. Residential programs served 38 peopleⁱⁱ, and supportive services only (SSO) programs served 99 peopleⁱⁱⁱ.



There were 81 households in the CoC, including: 59 households without children (containing 65 individuals), 18 households with both adults and children (containing 26 adults and 42 children), and 4 households of only unaccompanied minors (under 18 years of age), containing 4 minors^{iv}.

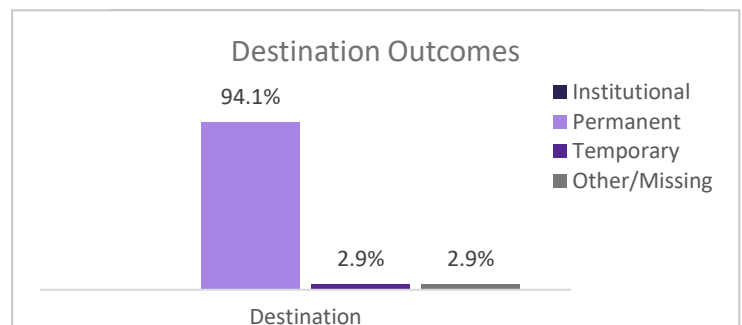
By gender, providers in the CoC served 65 (47.4%) women, 69 (50.4%) men, and 3 (2.2%) trans-identified individuals.

The racial and ethnic breakdown of those served included: 112 (81.8%) White, 17 (12.4%) Black or African-American, and 2 (1.5%) American Indian or Alaskan Native. 47 (34.3%) individuals identified as Hispanic/Latino regardless of race.

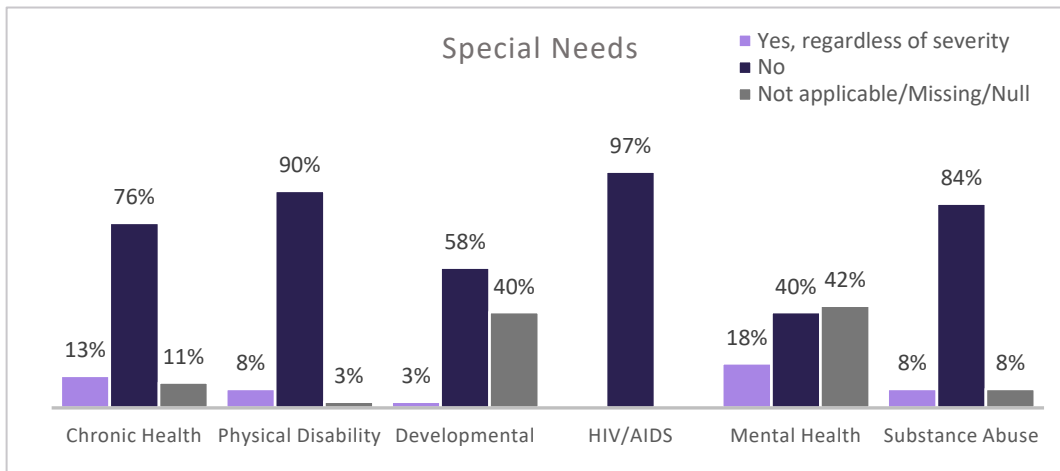


Of 95 adults or heads of household, 12 (12.6%) indicated a prior residence of Emergency Shelter, the streets, or Safe Haven. Of these clients, 7 (58.3%) reported no previous episodes of homelessness within the last three years. 4 (33.3%) reported that they had been 2 times homeless during the same time frame. 1 (8.3%) did not report on this data element.

The total number of individuals discharged during the quarter was 68, which included 37 adults and 31 children. 64 (94.1%) were discharged to a permanent destination. Of the clients over 18, income for 3 (8.1%) rose between admission and discharge, while 33 (89.2%) maintained stable income of greater than zero.



Special Needs – HUD and HHS Funded Programs Only



35.3% of adults (12/34) and no of children (0/4) in HUD or HHS funded programs self-reported at least one physical, emotional, or other health condition *regardless of whether the condition had become serious enough to be disabling*. When taking severity of condition into account,

4 adults reported conditions that met the criteria to be considered a disability.

Sub-Populations – All Programs

No individuals over 18 met the criteria for chronic homelessness at the time of project entry.^v 1 out of every 10.1 adults receiving services this quarter was a veteran (9.9%). Out of the 9 veterans served, 6 (66.7%) reported a disabling condition and none met the criteria for chronic homelessness at admission.
