This is the annual report for the CARES Regional Homeless Management Information System (CRHMIS). The CRHMIS reports follow the Federal Fiscal Year (FFY) of October 1<sup>st</sup> through September 30<sup>th</sup> rather than the calendar year.

Different project types have different reporting criteria and projects not funded through the Continuum of Care (CoC) may not collect more than the Universal Data Elements (UDEs), found in the 2016 Data Standards available under the User Resources tab of our website: http://www.caresny.org or via email (below).

This report includes homeless prevention and housing projects participating in the Homeless Management Information System (HMIS) for your community but does not include domestic violence providers, as per Federal Law, and may not include homeless programs by non-mandated providers who have chosen not to participate in the HMIS database.
