



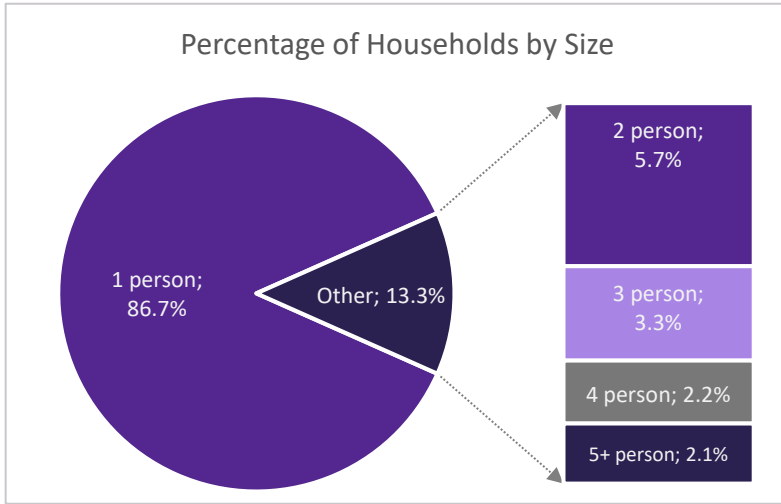

Overview – All Programs

Between 10/1/2017 and 12/31/2017, providers in the Schenectady City & County CoC served 2605 people experiencing or at risk of experiencing homelessnessⁱ. Residential programs served 1459 peopleⁱⁱ, and supportive services only (SSO) programs served 1229 peopleⁱⁱⁱ.

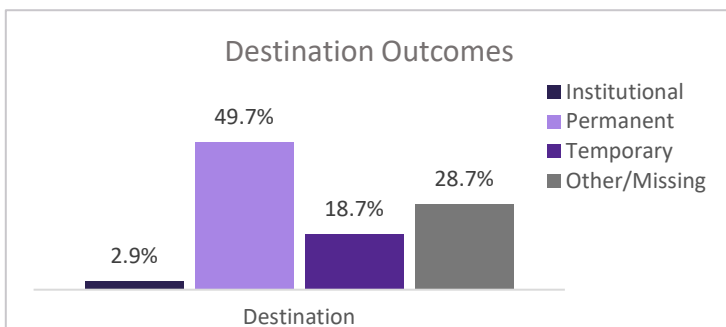
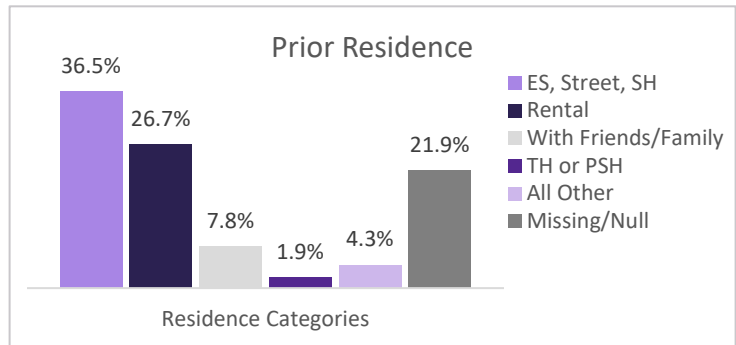


There were 2036 households in the CoC, including: 1703 households without children (containing 1733 individuals), 240 households with both adults and children (containing 314 adults and 462 children), and 93 households of only unaccompanied minors (under 18 years of age), containing 101 minors^{iv}.

By gender, providers in the CoC served 1304 (50.1%) women, 1273 (48.9%) men, and 6 (0.2%) trans-identified individuals.

The racial and ethnic breakdown of those served included: 1051 (40.3%) White, 1225 (47.0%) Black or African-American, 22 (0.8%) Asian, 34 (1.3%) Native Hawaiian or Other Pacific Islander, 34 (1.3%) American Indian or Alaskan Native, and 170 (6.5%) Multiple Races. 414 (15.9%) individuals identified as Hispanic/Latino regardless of race.

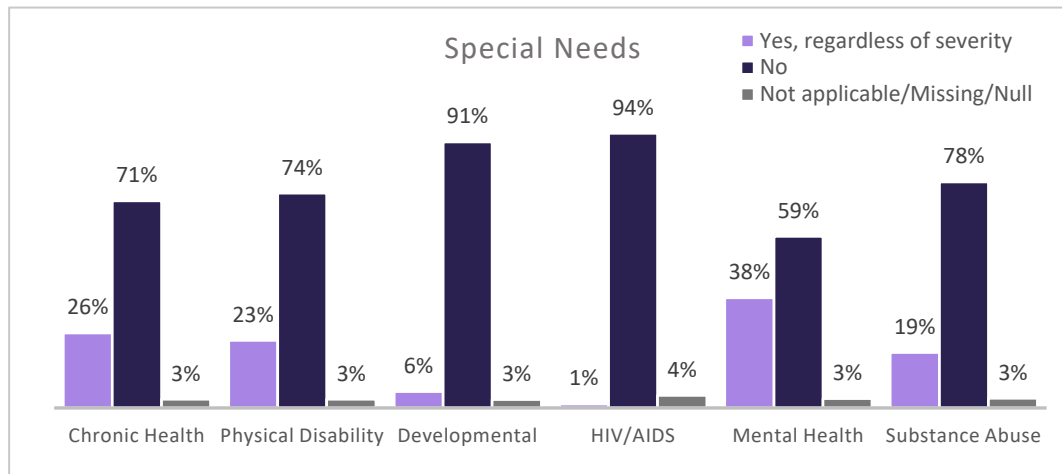
Of 2112 adults or heads of household, 771 (36.5%) indicated a prior residence of Emergency Shelter, the streets, or Safe Haven. Of these clients, 464 (60.2%) reported no previous episodes of homelessness within the last three years. 142 (18.4%), 58 (7.5%), and 151 (19.6%) reported that they had been 2, 3, or 4+ times homeless (respectively) during the same time frame. 25 (3.2%) did not report on this data element.



For the adults or heads of household who were in program a year or more and received an annual assessment (243), 135 (55.6%) saw an increase in income (cash and cash benefits) between admission and the most recent update, while 75 (30.9%) saw no change in income that was initially higher than zero^v.

The total number of individuals discharged during the quarter was 579, which included 378 adults and 201 children. 288 (49.7%) were discharged to a permanent destination. Income for 16 (4.2%) clients over 18 rose between admission and discharge, while 209 (55.3%) maintained stable income of greater than zero.

Special Needs – HUD and HHS Funded Programs Only



67.2% of adults (775/1153) and 15.6% of children (33/211) in HUD or HHS funded programs self-reported at least one physical, emotional, or other health condition *regardless of whether the condition had become serious enough to be disabling*. Among those reporting

multiple conditions, the most significant comorbidity was Mental Health and Substance Use (178). When taking severity of condition into account, 405 adults reported conditions that met the criteria to be considered a disability.

Sub-Populations – All Programs

80 (3.9%) individuals over 18 met the criteria for chronic homelessness at the time of project entry.^{vi} 1 out of every 17.0 adults receiving services this quarter was a veteran (5.9%). Out of the 120 veterans served, 54 (45.0%) reported a disabling condition and 8 (6.7%) met the criteria for chronic homelessness at admission.
