

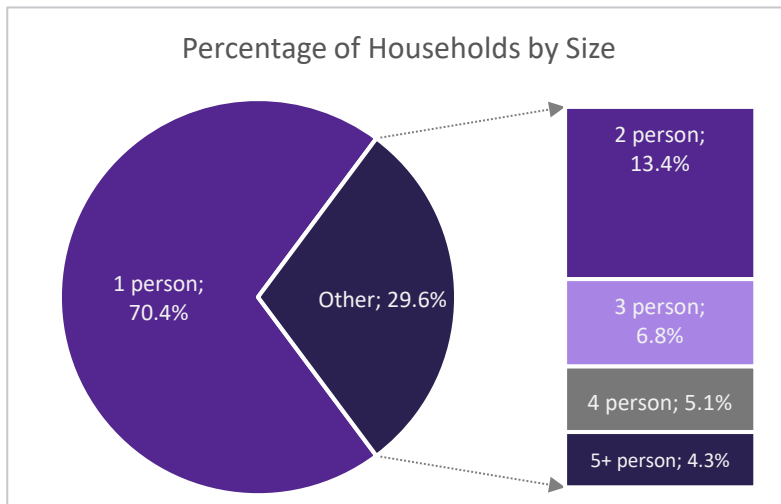

Overview – All Programs

Between 10/1/2017 and 12/31/2017, providers in the Clinton County CoC served 641 people experiencing or at risk of experiencing homelessnessⁱ. Residential programs served 130 peopleⁱⁱ, and supportive services only (SSO) programs served 527 peopleⁱⁱⁱ.



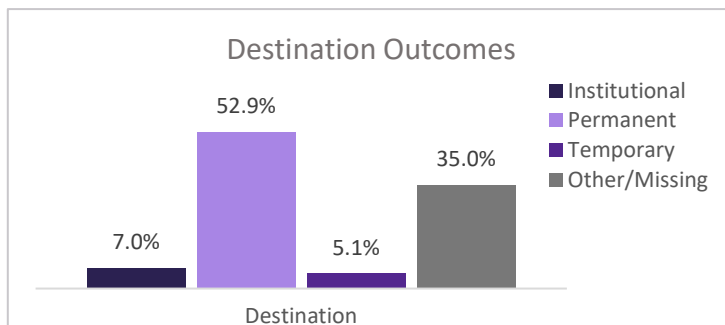
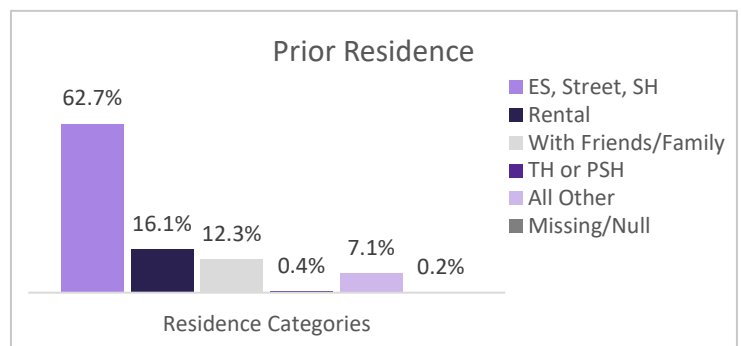
There were 395 households in the CoC, including: 292 households without children (containing 314 individuals), 94 households with both adults and children (containing 132 adults and 185 children), and 9 households of only unaccompanied minors (under 18 years of age), containing 10 minors^{iv}.

By gender, providers in the CoC served 296 (46.2%) women and 345 (53.8%) men.

The racial and ethnic breakdown of those served included: 555 (86.6%) White, 34 (5.3%)

Black or African-American, 7 (1.1%) American Indian or Alaskan Native, and 38 (5.9%) Multiple Races. 30 (4.7%) individuals identified as Hispanic/Latino regardless of race.

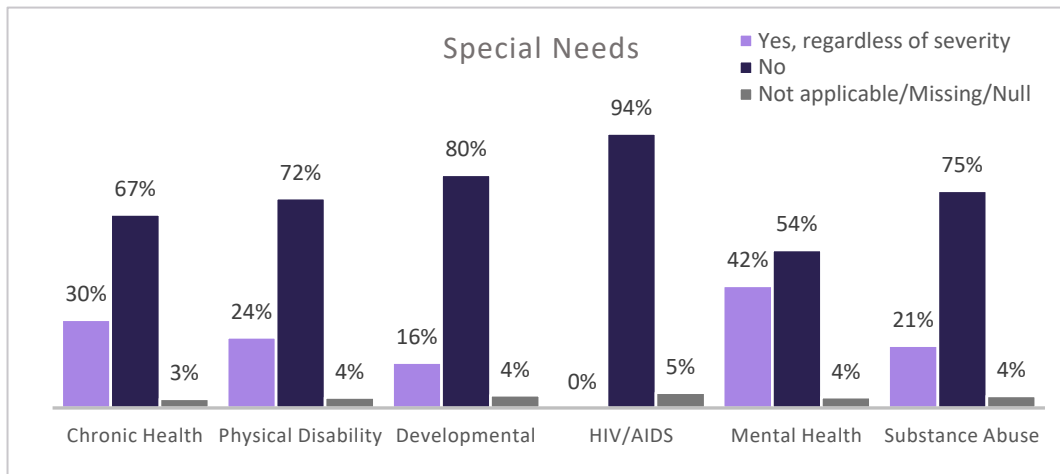
Of 448 adults or heads of household, 281 (62.7%) indicated a prior residence of Emergency Shelter, the streets, or Safe Haven. Of these clients, 189 (67.3%) reported no previous episodes of homelessness within the last three years. 49 (17.4%), 15 (5.3%), and 19 (6.8%) reported that they had been 2, 3, or 4+ times homeless (respectively) during the same time frame. 10 (3.6%) did not report on this data element.



For the adults or heads of household who were in program a year or more and received an annual assessment (19), 11 (57.9%) saw an increase in income (cash and cash benefits) between admission and the most recent update, while 3 (15.8%) saw no change in income that was initially higher than zero^v.

The total number of individuals discharged during the quarter was 157, which included 99 adults and 58 children. 83 (52.9%) were discharged to a permanent destination. Income for 2 (2.0%) clients over 18 rose between admission and discharge, while 96 (97.0%) maintained stable income of greater than zero.

Special Needs – HUD and HHS Funded Programs Only



78.7% of adults (332/422) and 34.9% of children (68/195) in HUD or HHS funded programs self-reported at least one physical, emotional, or other health condition *regardless of whether the condition had become serious enough to be disabling*. Among those reporting

multiple conditions, the most significant comorbidity was Mental Health and Substance Use (92). When taking severity of condition into account, 234 adults reported conditions that met the criteria to be considered a disability.

Sub-Populations – All Programs

11 (2.5%) individuals over 18 met the criteria for chronic homelessness at the time of project entry.^{vi} 1 out of every 13.5 adults receiving services this quarter was a veteran (7.4%). Out of the 33 veterans served, 15 (45.5%) reported a disabling condition and 2 (6.1%) met the criteria for chronic homelessness at admission. 66 clients (14.8%) were considered youth, aged 18- 24 years.
