


Quarterly Report

NY-601 - Poughkeepsie/Dutchess County CoC

10/1/2017-12/31/2017

<u>Overview – All Programs</u>

Between 10/1/2017 and 12/31/2017, providers in the Poughkeepsie/Dutchess County CoC served 1208 people experiencing or at risk of experiencing homelessnessⁱ. Residential programs served 981 peopleⁱⁱ, and supportive services only (SSO) programs served 301 peopleⁱⁱⁱ.





There were 967 households in the CoC, including: 839 households without children (containing 855 individuals), 99 households with both adults and children (containing 124 adults and 197 children), and 29 households of only unaccompanied minors (under 18 years of age), containing 32 minors^{iv}.

By gender, providers in the CoC served 512 (42.4%) women, 694 (57.5%) men, and 2 (0.2%) trans-identified individuals.

The racial and ethnic breakdown of those served included: 517 (42.8%) White, 616 (51.0%) Black or African-American, 5 (0.4%) Asian, 2 (0.2%) Native Hawaiian or Other Pacific Islander, 8 (0.7%) American Indian or Alaskan Native, and 53 (4.4%) Multiple Races. 161 (13.3%) individuals identified as Hispanic/Latino regardless of race.

Of 1004 adults or heads of household, 375 (37.4%) indicated a prior residence of Emergency Shelter, the streets, or Safe Haven. Of these clients, 210 (56.0%) reported no previous episodes of homelessness within the last three years. 83 (22.1%), 38 (10.1%), and 41 (10.9%) reported that they had been 2, 3, or 4+ times homeless (respectively) during the same time frame. 5 (1.3%) did not report on this data element.






For the adults or heads of household who were in program a year or more and received an annual assessment (192), 59 (30.7%) saw an increase in income (cash and cash benefits) between admission and the most recent update, while 119 (62.0%) saw no change in income that was initially higher than zero^v.

The total number of individuals discharged during the quarter was 397, which included 324 adults and 73 children. 91 (22.9%) were discharged to a permanent destination. Income for 8 (2.5%) clients over 18 rose between admission and discharge, while 306 (94.4%) maintained stable income of greater than zero.

Special Needs – HUD and HHS Funded Programs Only



66.1% of adults (565/855) and 19.0% of children (34/179) in HUD or HHS funded programs self-reported at least one physical, emotional, or other health condition regardless of whether condition become serious enough to be disabling. Among those reporting

multiple conditions, the most significant comorbidity was Mental Health and Substance Use (197). When taking severity of condition into account, 371 adults reported conditions that met the criteria to be considered a disability.

Sub-Populations – **All Programs**

50 (5.1%) individuals over 18 met the criteria for chronic homelessness at the time of project entry. ¹ 1 out of every 16.3 adults receiving services this quarter was a veteran (6.1%). Out of the 60 veterans served, 22 (36.7%) reported a disabling condition and 3 (5.0%) met the criteria for chronic homelessness at admission.
