



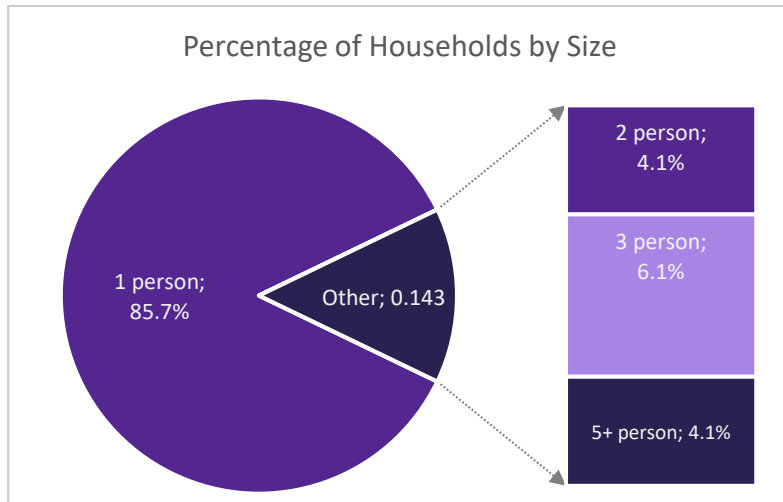
## Quarterly Report

# NY-506 - Fulton Montgomery Schoharie Counties CoC

4/1/2018-6/30/2018

### Overview – All Programs

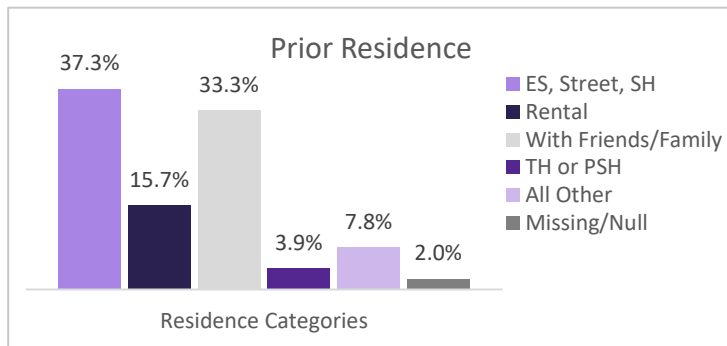
Between 4/1/2018 and 6/30/2018, providers in the Fulton/Montgomery/Schoharie Counties CoC served 65 people experiencing or at risk of experiencing homelessness<sup>i</sup>. Residential programs served 36 people<sup>ii</sup>, and supportive services only (SSO) programs served 29 people<sup>iii</sup>.



There were 49 households in the CoC, including: 38 households without children (containing 38 individuals), 7 households with both adults and children (containing 9 adults and 14 children), and 4 households of only unaccompanied minors (under 18 years of age), containing 4 minors<sup>iv</sup>.

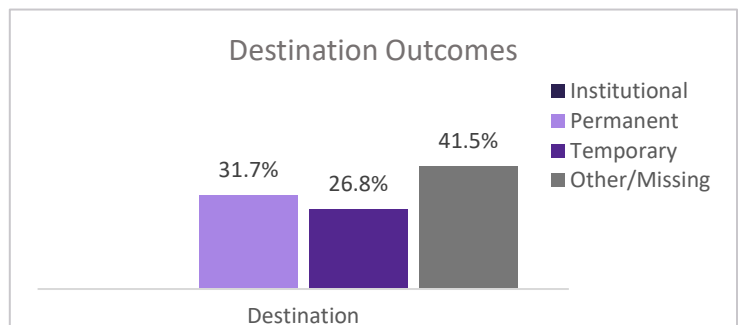
By gender, providers in the CoC served 28 (43.1%) women, 34 (52.3%) men, and 3 (4.6%) trans-identified individuals.

The racial and ethnic breakdown of those served included: 51 (78.5%) White, 7 (10.8%) Black or African-American, and 1 (1.5%) Multiple Races. 13 (20.0%) individuals identified as Hispanic/Latino regardless of race.



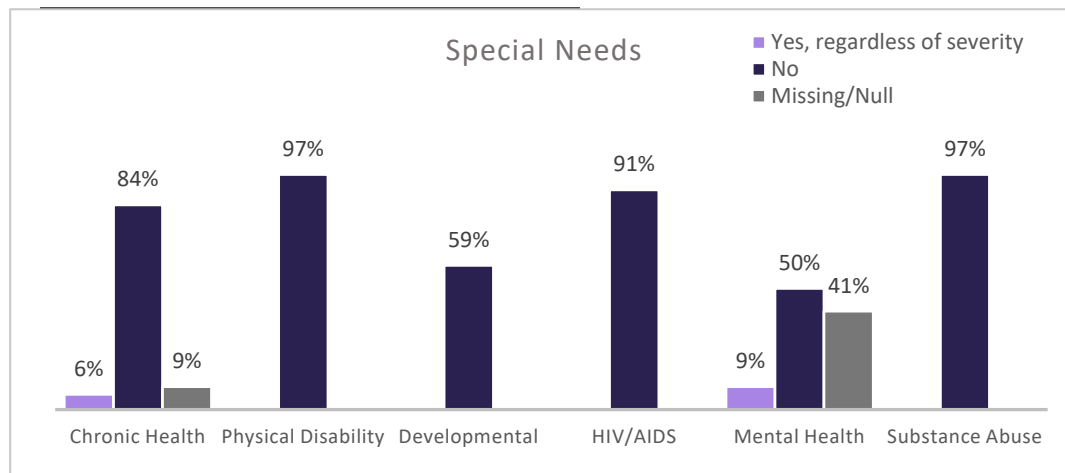
Of 51 adults or heads of household, 19 (37.3%) indicated a prior residence of Emergency Shelter, the streets, or Safe Haven. Of these clients, 10 (52.6%) reported no previous episodes of homelessness within the last three years. 6 (31.6%) and 4 (21.1%) reported that they had been 2 or 4+ times homeless (respectively) during the same time frame.

The total number of individuals discharged during the quarter was 41, which included 28 adults and 13 children. 13 (31.7%) were discharged to a permanent destination. Income for 4 (14.3%) clients over 18 rose between admission and discharge, while 8 (28.6%) maintained stable income of greater than zero.



## **Special Needs – HUD and HHS Funded Programs Only**

20.0% of adults (4/20) and no children (0/12) in HUD or HHS funded programs self-reported at least one



physical, emotional, or other health condition *regardless of whether the condition had become serious enough to be disabling*. When taking severity of condition into account, 1 adults reported conditions that met the criteria to be considered a disability.

## **Sub-Populations – All Programs**

1 (2.1%) individuals over 18 met the criteria for chronic homelessness at the time of project entry.<sup>v</sup> 1 out of every 7.8 adults receiving services this quarter was a veteran (12.8%).
