



NY-512 - Troy/Rensselaer County CoC

Overview - All Programs


Between 1/1/2018 and 3/31/2018, providers in the Troy/Rensselaer County CoC served 1304 people experiencing or at risk of experiencing homelessnessⁱ. Residential programs served 1051 peopleⁱⁱ, and supportive services only (SSO) programs served 271 peopleⁱⁱⁱ.



There were 829 households in the CoC, including: 617 households without children (containing 641 individuals), 198 households with both adults and children (containing 260 adults and 398 children), and 14 households of only unaccompanied minors (under 18 years of age), containing 16 minors^{iv}.


By gender, providers in the CoC served 664 (50.9%) women, 636 (48.8%) men, and 3 (0.2%) trans-identified individuals.

The racial and ethnic breakdown of those served included: 631 (48.4%) White, 524 (40.2%) Black or African-American, 6 (0.5%) Asian, 7 (0.5%) Native Hawaiian or Other Pacific Islander, 13 (1.0%) American Indian or Alaskan Native, and 88 (6.7%) Multiple Races. 197 (15.1%) individuals identified as Hispanic/Latino regardless of race.



Of 904 adults or heads of household, 475 (52.5%) indicated a prior residence of Emergency Shelter, the streets, or Safe Haven. Of these clients, 199 (41.9%) reported no previous episodes of homelessness within the last three years. 92 (19.4%), 46 (9.7%), and 154 (32.4%) reported that they had been 2, 3, or 4+ times homeless (respectively) during the same time frame. 19 (4.0%) did not report on this data element.

For the adults or heads of household who were in program a year or more and received an annual assessment (216), 124 (57.4%) saw an increase in income (cash and cash benefits) between admission and the most recent update, while 15 (6.9%) saw no change in income that was initially higher than zero^v.




The total number of individuals discharged during the quarter was 493, which included 361 adults and 132 children. 249 (50.5%) were discharged to a permanent destination. Income for 12 (3.3%) clients over 18 rose between admission and discharge, while 115 (31.9%) maintained stable income of greater than zero.

<u>Sub-Populations – All Programs</u>

88 (9.8%) individuals over 18 met the criteria for chronic homelessness at the time of project entry. ^{vi} 1 out of every 22.5 adults receiving services this quarter was a veteran (4.5%). Out of the 40 veterans served, 24 (60.0%) reported a disabling condition and 4 (10.0%) met the criteria for chronic homelessness at admission. Of all clients, 114 (12.7%) were considered youth (aged 18- 24 years).

Special Needs – HUD and HHS Funded Programs Only



71.3% of adults (410/575) and 18.6% of children (65/349) in HUD or HHS funded programs self-reported at least one physical, emotional, or other health condition *regardless of whether the condition had become serious enough to be disabling*. Among those reporting multiple conditions, the most significant comorbidity was Mental Health and Substance Use (154). When taking severity of condition into account, 311 adults reported conditions that met the criteria to be considered a disability.
