


Quarterly Report

NY-522 – Jefferson, Lewis, St. Lawrence Counties CoC

1/1/2018-3/31/2018

<u>Overview – All Programs</u>

Between 1/1/2018 and 3/31/2018, providers in the Jefferson, Lewis, St. Lawrence Counties CoC served 1188 people experiencing or at risk of experiencing homelessnessⁱ. Residential programs served 773 peopleⁱⁱ, and supportive services only (SSO) programs served 427 peopleⁱⁱⁱ.




There were 732 households in the CoC, including: 540 households without children (containing 584 individuals), 183 households with both adults and children (containing 259 adults and 339 children), and 9 households of only unaccompanied minors (under 18 years of age), containing 14 minors^{iv}.

By gender, providers in the CoC served 578 (48.7%) women, 610 (51.3%) men, and no trans-identified individuals.


The racial and ethnic breakdown of those

served included: 1038 (87.4%) White, 104 (8.8%) Black or African-American, 3 (0.3%) Native Hawaiian or Other Pacific Islander, 11 (0.9%) American Indian or Alaskan Native, and 32 (2.7%) Multiple Races. 51 (4.3%) individuals identified as Hispanic/Latino regardless of race.



Of 841 adults or heads of household, 297 (35.3%) indicated a prior residence of Emergency Shelter, the streets, or Safe Haven. Of these clients, 177 (59.6%) reported no previous episodes of homelessness within the last three years. 70 (23.6%), 21 (7.1%), and 27 (9.1%) reported that they had been 2, 3, or 4+ times homeless (respectively) during the same time frame. 2 (0.7%) did not report on this data element.


For the adults or heads of household who were in program a year or more and received an annual assessment (122), 32 (26.2%) saw an increase in income (cash and cash benefits) between admission and the most recent update, while 41 (33.6%) saw no change in income that was initially higher than zero^v.



The total number of individuals discharged during the quarter was 439, which included 312 adults and 127 children. 372 (84.7%) were discharged to a permanent destination. Income for 8 (2.6%) clients over 18 rose between admission and discharge, while 169 (54.2%) maintained stable income of greater than zero.

Sub-Populations – All Programs

14 (1.7%) individuals over 18 met the criteria for chronic homelessness at the time of project entry.^{vi} 1 out of every 21.6 adults receiving services this quarter was a veteran (4.6%). Out of the 39 veterans served, 19 (48.7%) reported a disabling condition. Of all clients, 132 (15.7%) were considered youth (aged 18- 24 years).



Special Needs – HUD and HHS Funded Programs Only

72.1% of adults (416/577) and 14.5% of children (36/248) in HUD or HHS funded programs self-reported at least one physical, emotional, or other health condition *regardless of whether the condition had become serious enough to be disabling*. Among those reporting multiple conditions, the most significant comorbidity was Mental Health and Substance Use (79). When taking severity of condition into account, 250 adults reported conditions that met the criteria to be considered a disability.
