# HMIS Data Clean Up



As we prepare for the upcoming LSA (formerly known as AHAR) submission we will be reaching out to projects that may need to do some data clean up. I am hopeful that there won't be too much as you all did such a wonderful job when we were preparing the System Performance Measures Report last spring.

## **HMIS System Administrator Call 8/28/18**



Here are a few of the updates that were covered on the last HMIS System Administrator call held on 8/29/18:

Coordinated Entry: HUD is designing the CE APR in SAGE to look more like the HMIS Dedicated APR, meaning less HMIS data (though there will be some) and relying more on narrative. We can all breathe a sigh of relief.

**CSV Files:** Any CoC projects that are due to submit APR's in October, we are asking that you please hold off on doing so until 10/10, as SAGE will only be accepting the newest CSV file version effective 10/1. While this would normally not cause an issue, the newest CSV file version will not be available in our database until 10/10 to allow SSVF projects to perform their CSV upload to the VA using the current

CSV version. If you have any questions, please call Kelli at 518-489-4130 ext 113.

**Federal Partner Data Manuals:** Each of the Federal Partners have updated their program manuals and will be releasing them this month. There are no changes/updates to any of the data elements, just clarification on data collection. As soon as they are released we will have them available on our website.

Rapid Rehousing Evictions: Though this may not have come up in any of your RRH projects, HUD has clarified how client evections should be recorded in HMIS: If a client in a RRH project has been permanently housed (a permanent housing placement date has been recorded), but loses that housing while still enrolled in the project the client needs to be discharged back to homelessness in the HMIS and then readmitted into the RRH project if it is decided that the project will begin a housing search with the client again. It was clarified that the discharge date from the enrollment where the housing was lost and the admission date for the new enrollment can be the same date. Projects are not to delete the Permanently Housed date if a client loses their housing. Again, call Kelli if you have any questions
