



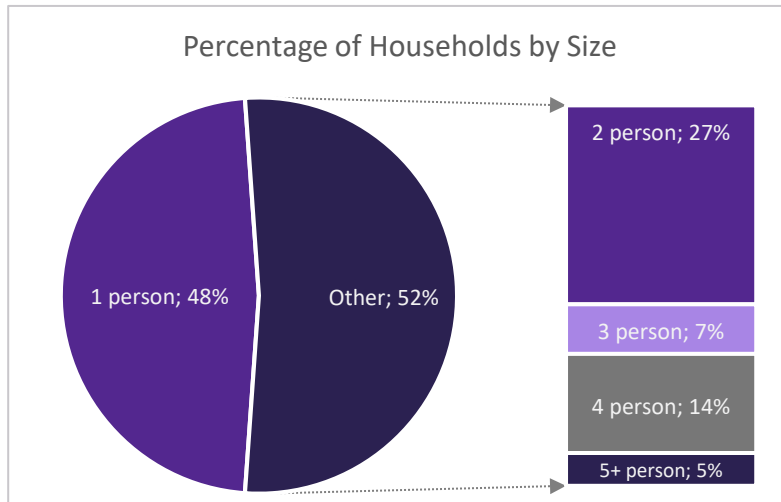
## Quarterly Report

# NY-519 - Columbia/Greene County CoC

4/1/2018-6/30/2018

### Overview – All Programs

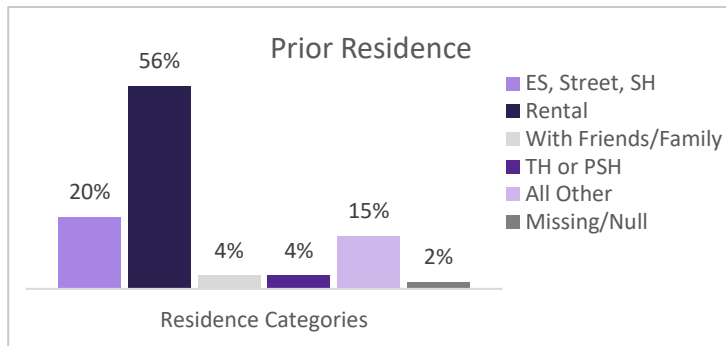
Between 4/1/2018 and 6/30/2018, providers in the Columbia/Greene County CoC served 89 people experiencing or at risk of experiencing homelessness<sup>i</sup>. Residential programs served 31 people<sup>ii</sup>, and supportive services only (SSO) programs served 58 people<sup>iii</sup>.



There were 44 households in the CoC, including: 25 households without children (containing 29 individuals), 19 households with both adults and children (containing 26 adults and 34 children), and no households of only unaccompanied minors (under 18 years of age).<sup>iv</sup>

By gender, providers in the CoC served 50 (56.2%) women, 39 (43.8%) men, and no trans-identified individuals.

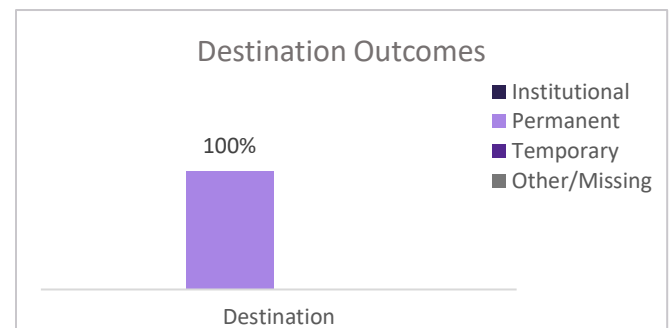
The racial and ethnic breakdown of those served included: 60 (67.4%) White, 18 (20.2%) Black or African-American, and 10 (11.2%) Multiple Races. 3 (3.4%) individuals identified as Hispanic/Latino regardless of race.



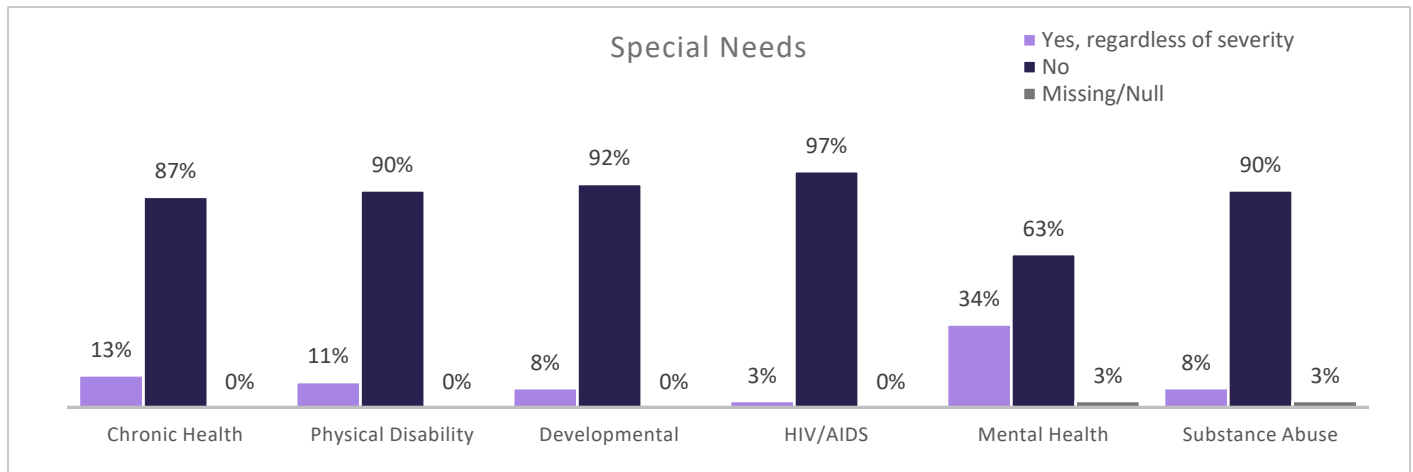
Of 55 adults or heads of household, 11 (20.0%) indicated a prior residence of Emergency Shelter, the streets, or Safe Haven. Of these clients, 6 (54.5%) reported no previous episodes of homelessness within the last three years. 1 (9.1%), 1 (9.1%), and 2 (18.2%) reported that they had been 2, 3, or 4+ times homeless (respectively) during the same time frame. 1 (9.1%) did not report on this data element.

For the adults or heads of household who were in program a year or more and received an annual assessment (10), 8 (80.0%) saw an increase in income (cash and cash benefits) between admission and the most recent update<sup>v</sup>.

The total number of individuals discharged during the quarter was 19, which included 10 adults and 9 children. 19 (100.0%) were discharged to a permanent destination. Income for all 10 clients over 18 (100.0%) maintained stable income of greater than zero.



## **Special Needs – HUD and HHS Funded Programs Only**



63.0% of adults (17/27) and 18.2% of children (2/11) in HUD or HHS funded programs self-reported at least one physical, emotional, or other health condition *regardless of whether the condition had become serious enough to be disabling*. When taking severity of condition into account, 8 adults reported conditions that met the criteria to be considered a disability.

### **Sub-Populations – All Programs**

2 (3.6%) individuals over 18 met the criteria for chronic homelessness at the time of project entry.<sup>vi</sup> 1 out of every 55.0 adults receiving services this quarter was a veteran (1.8%).
