


# **Quarterly Report**

## NY-520 - Franklin & Essex Counties CoC

4/1/2018-6/30/2018

### Overview - All Programs


Between 4/1/2018 and 6/30/2018, providers in the Franklin & Essex Counties CoC served 100 people experiencing or at risk of experiencing homelessness<sup>i</sup> in residential programs.<sup>ii</sup>



There were 75 households in the CoC, including: 62 households without children (containing 62 individuals), 13 households with both adults and children (containing 16 adults and 22 children), and no households of only unaccompanied minors (under 18 years of age).<sup>iii</sup>

By gender, providers in the CoC served 39 (39.0%) women, 60 (60.0%) men, and 1 (1.0%) trans-identified individual.

The racial and ethnic breakdown of those served included: 81 (81.0%) White, 2 (2.0%) Black or African-American, 1 (1.0%) Asian, 6 (6.0%) American Indian or Alaskan Native, and 8 (8.0%) Multiple Races. 2 (2.0%) individuals identified as Hispanic/Latino regardless of race.



Of 78 adults or heads of household, 37 (47.4%) indicated a prior residence of Emergency Shelter, the streets, or Safe Haven. Of these clients, 26 (70.3%) reported no previous episodes of homelessness within the last three years. 3 (8.1%), 3 (8.1%), and 2 (5.4%) reported that they had been 2, 3, or 4+ times homeless (respectively) during the same time frame. 4 (10.8%) did not

report on this data element.

For the adults or heads of household who were in program a year or more and received an annual assessment (9), 3 (33.3%) saw an increase in income (cash and cash benefits) between admission and the most recent update, while 2 (22.2%) saw no change in income that was initially higher than zero<sup>iv</sup>.




The total number of individuals discharged during

the quarter was 45, which included 38 adults and 7 children. 27 (60.0%) were discharged to a permanent

destination. Income for 4 (10.5%) clients over 18 rose between admission and discharge, while 34 (89.5%) maintained stable income of greater than zero.

## <u>Special Needs – HUD and HHS Funded Programs Only</u>



62.5% of adults (10/16) and 16.7% of children (2/12) in HUD or HHS funded programs self-reported at least one physical, emotional, or other health condition *regardless of whether the condition had become serious enough to be disabling*. When taking severity of condition into account, 6 adults reported conditions that met the criteria to be considered a disability.

### <u>Sub-Populations – All Programs</u>

No individuals over 18 met the criteria for chronic homelessness at the time of project entry. ¹ 1 out of every 13.0 adults receiving services this quarter was a veteran (7.7%). Out of the 6 veterans served, 2 (33.3%) reported a disabling condition and none met the criteria for chronic homelessness at admission.
