


# **Quarterly Report**

# NY-523 - Glen Falls/Saratoga Springs/Saratoga County CoC

4/1/2018-6/30/2018

## Overview - All Programs

Between 4/1/2018 and 6/30/2018, providers in the Glen Falls/Saratoga Springs/Saratoga County CoC served 664 people experiencing or at risk of experiencing homelessness<sup>i</sup>. Residential programs served 446 people<sup>ii</sup>, and supportive services only (SSO) programs served 224 people<sup>iii</sup>.




There were 506 households in the CoC, including: 389 households without children (containing 406 individuals), 68 households with both adults and children (containing 85 adults and 127 children), and 49 households of only unaccompanied minors (under 18 years of age), containing 50 minors<sup>iv</sup>.

By gender, providers in the CoC served 266 (40.1%) women, 370 (55.7%) men, and 9 (1.4%) trans-identified individuals.


The racial and ethnic breakdown of those

served included: 503 (75.8%) White, 91 (13.7%) Black or African-American, 3 (0.5%) Asian, 3 (0.5%) American Indian or Alaskan Native, and 33 (5.0%) Multiple Races. 34 (5.1%) individuals identified as Hispanic/Latino regardless of race.




Of 533 adults or heads of household, 201 (37.7%) indicated a prior residence of Emergency Shelter, the streets, or Safe Haven. Of these clients, 74 (36.8%) reported no previous episodes of homelessness within the last three years. 46 (22.9%), 22 (10.9%), and 51 (25.4%) reported that they had been 2, 3, or 4+ times homeless (respectively) during the same time frame. 15 (7.5%) did not report on this data element.

For the adults or heads of household who were in program a year or more and received an annual assessment (85), 47 (55.3%) saw an increase in income (cash and cash benefits) between admission and the most recent update, while 20 (23.5%) saw no change in income that was initially higher than zero<sup>v</sup>.



The total number of individuals discharged during the quarter was 312, which included 229 adults and 83 children. 170 (54.5%) were discharged to a permanent destination. Income for 23 (10.0%) clients over 18 rose between admission and discharge, while 129 (56.3%) maintained stable income of greater than zero.

## <u>Special Needs – HUD and HHS Funded Programs Only</u>



61.1% of adults (138/226) and 26.0% of children (33/127) in HUD or HHS funded programs self-reported at least one physical, emotional, or other health condition regardless of whether condition had become serious enough to be disabling. Among those reporting

multiple conditions, the most significant comorbidity was Mental Health and Substance Use (35). When taking severity of condition into account, 76 adults reported conditions that met the criteria to be considered a disability.

## <u>Sub-Populations – All Programs</u>

29 (6.0%) individuals over 18 met the criteria for chronic homelessness at the time of project entry. <sup>vi</sup> 1 out of every 3.9 adults receiving services this quarter was a veteran (25.7%). Out of the 125 veterans served, 69 (55.2%) reported a disabling condition and 17 (13.6%) met the criteria for chronic homelessness at admission. Of all clients, 110 (22.6%) were considered youth, aged 18-24 years.
