


# **Quarterly Report**

# NY-606 - Rockland County CoC

4/1/2018-6/30/2018

## Overview - All Programs


Between 4/1/2018 and 6/30/2018, providers in the Rockland County CoC served 1007 people experiencing or at risk of experiencing homelessness<sup>i</sup>. Residential programs served 228 people<sup>ii</sup>, and supportive services only (SSO) programs served 782 people<sup>iii</sup>.



There were 477 households in the CoC, including: 309 households without children (containing 415 individuals), 157 households with both adults and children (containing 282 adults and 295 children), and 11 households of only unaccompanied minors (under 18 years of age), containing 15 minors<sup>iv</sup>.


By gender, providers in the CoC served 527 (52.3%) women, 439 (43.6%) men, and no trans-identified individuals.

The racial and ethnic breakdown of those served included: 283 (28.1%) White, 415 (41.2%) Black or African-American, 3 (0.3%) Asian, 2 (0.2%) American Indian or Alaskan Native, and 9 (0.9%) Multiple Races. 141 (14.0%) individuals identified as Hispanic/Latino regardless of race.



Of 699 adults or heads of household, 47 (6.7%) indicated a prior residence of Emergency Shelter, the streets, or Safe Haven. Of these clients, 23 (48.9%) reported no previous episodes of homelessness within the last three years. 5 (10.6%), 3 (6.4%), and 10 (21.3%) reported that they had been 2, 3, or 4+ times homeless (respectively) during the same time frame. 6 (12.8%) did not report on this data element.


For the adults or heads of household who were in program a year or more and received an annual assessment (3), 1 (33.3%) saw an increase in income (cash and cash benefits) between admission and the most recent update, while 1 (33.3%) saw no change in income that was initially higher than zero.



The total number of individuals discharged during the quarter was 79, which included 77 adults and 2 children. 5 (6.3%) were discharged to a permanent destination. Income for 2 (2.6%) clients over 18 rose between admission and discharge, while 14 (18.2%) maintained stable income of greater than zero.

## <u>Special Needs – HUD and HHS Funded Programs Only</u>

4.1% of adults (23/562) and 1.8% of children (5/282) in HUD or HHS funded programs self-reported at least



one physical, emotional, or other health condition regardless of whether the condition had become serious enough to be disabling. Among those reporting multiple conditions, the most significant comorbidity was Mental Health and Substance Use (5).

When taking severity of condition into account, 16 adults reported conditions that met the criteria to be considered a disability.

## <u>Sub-Populations – All Programs</u>

5 (0.7%) individuals over 18 met the criteria for chronic homelessness at the time of project entry. <sup>vi</sup> 1 out of every 26.8 adults receiving services this quarter was a veteran (3.7%). Out of the 26 veterans served, 10 (38.5%) reported a disabling condition and 2 (7.7%) met the criteria for chronic homelessness at admission.
