


Federal Fiscal Year 2018 Annual Report

NY-507 - Schenectady City & County CoC

<u>Overview – All Programs</u>

Between 10/1/2017 and 9/30/2018, providers in the Schenectady served 4161 people experiencing or at risk of experiencing homelessness.ⁱ Residential programs served 2673 peopleⁱⁱ, and supportive services only (SSO) programs served 1488 people.ⁱⁱⁱ




There were 2516 households in the CoC, including: 1997 households without children (containing 2068 individuals), 411 households with both adults and children (containing 554 adults and 837 children), and 108 households of only unaccompanied minors (under 18 years of age), containing 126 minors. iv

By gender, providers in the CoC served 1721 (41.4%) women, 1835 (44.1%) men, 8 (0.2%) trans-identified individuals, and 1 (0.0%) gender non-conforming individuals.


The racial breakdown of those served included: 1349 (32.4%) White, 1721 (41.4%) Black or African-American, 27 (0.6%) Asian, 28 (0.7%) Native Hawaiian or Other Pacific Islander, 42 (1.0%) American Indian or Alaskan Native, and 355 (8.5%) Multiple Races. Regardless of race, 643 (15.5%) individuals identified as Hispanic/Latino in ethnicity.

Of 2681 adults or heads of household, 1338 (49.9%) indicated a prior residence of Emergency Shelter, the streets, or Safe Haven. Of these clients, 745 (55.7%) reported one previous episode of homelessness within the last three years. 229 (17.1%), 91 (6.8%), and 237 (17.7%) reported that they had been 2, 3, or 4+ times homeless (respectively) during the same time frame. 36 (2.7%) did not report on this data element.




Of the adults or heads of household who were in program a year or more and received an annual assessment (291), 102 (35.1%) saw an increase in income (cash and cash benefits) between admission and their most recent update, while 70 (24.1%) maintained a stable income of greater than zero.

The total number of individuals discharged during the year was 2200, which included 1558 adults and 642 children. 1479 (67.2%) were discharged to a permanent destination. Between admission and discharge, income for 54 (3.5%) clients over 18 rose, while 616 (39.5%) clients over 18 maintained a stable income of greater than zero.



Special Needs - HUD and HHS Funded Programs Only



57.2% of adults (832/1454) and 16.5% of children (95/577) in HUD or HHS funded programs self-reported at least one physical, emotional, or other health condition *regardless of whether the condition had become serious enough to be disabling*. Among those reporting multiple conditions, the most significant comorbidity was Mental Health and Substance Use (218). When taking severity of condition into account, 571 adults reported conditions that met the criteria to be considered a disability.^{vii}

<u>Sub-Populations – All Programs</u>

150 (6.2%) individuals over 18 met the criteria for chronic homelessness at the time of project entry. 1 out of every 16.9 adults receiving services this year was a veteran (5.9%). Out of the 144 veterans served, 86 (59.7%) reported a disabling condition and 14 (9.7%) met the criteria for chronic homelessness at admission. At admission, 453 clients (17.3%) of all clients were considered youth (18-24 years of age.)
