


Federal Fiscal Year **2019 Quarter 1** Report

NY-519 - Columbia/Greene County CoC

10/1/2018 - 12/31/2018

Overview - All Programs

Between 10/1/2018 and 12/31/2018, providers in the Columbia & Greene Counties CoC served 134 people experiencing or at risk of experiencing homelessness.ⁱ Residential programs served 76 peopleⁱⁱ, and supportive services only (SSO) programs served 58 people.ⁱⁱⁱ




There were 71 households in the CoC, including: 48 households without children (containing 57 individuals), 23 households with both adults and children (containing 35 adults and 42 children), and 0 households of only unaccompanied minors (under 18 years of age), containing 0 minors.^{iv}

By gender, providers in the CoC served 75 (56.0%) women, 59 (44.0%) men, and no trans-identified or gender non-conforming individuals.


The racial breakdown of those served included: 100 (74.6%) White, 13 (9.7%) Black or African-American, and 19 (14.2%) Multiple Races. Regardless of race, 11 (8.2%) individuals identified as Hispanic/Latino in ethnicity. ethnicity.

Of 92 adults or heads of household, 37 (40.2%) indicated a prior residence of Emergency Shelter, the streets, or Safe Haven. Of these clients, 16 (43.2%) reported one previous episode of homelessness within the last three years. 3 (8.1%), 5 (13.5%), and 11 (29.7%) reported that they had been 2, 3, or 4+ times homeless (respectively) during the same time frame. 2 (5.4%) did not report on this data element.


Of the adults or heads of household who were in program a year or more and received an annual assessment (25), 12 (48.0%) saw an increase in income (cash and cash benefits) between admission and their most recent update, while 2 (8.0%) maintained a stable income of greater than zero.



The total number of individuals discharged during the quarter was 38, which included 27 adults and 11 children. 34 (89.5%) were discharged to a permanent destination. Between admission and discharge, income for 1 (3.7%) clients over 18 rose, while 16 (59.3%) clients over 18 maintained a stable income of greater than zero.



<u>Special Needs – HUD and HHS Funded Programs Only</u>



72.4% of adults (63/87) and 21.4% of children (9/42) in HUD or HHS funded programs self-reported at least one physical, emotional, or other health condition *regardless of whether the condition had become serious enough to be disabling*. Among those reporting multiple conditions, the most significant comorbidity was Mental Health and Substance Use (17). When taking severity of condition into account, 47 adults reported conditions that met the criteria to be considered a disability.^{vii}

Sub-Populations - All Programs

16 (18.4%) individuals over 18 met the criteria for chronic homelessness at the time of project entry. 1 out of every 17.4 adults receiving services this quarter was a veteran (5.7%). Out of the 5 veterans served, 4 (80.0%) reported a disabling condition and 1 (20.0%) met the criteria for chronic homelessness at admission. At admission, 12 clients (13.0%) of all clients were considered youth (18-24 years of age.)

For these 'Persons Served' numbers only: if an individual client is served by **BOTH** Residential and Supportive Services programs within the same quarter, the client is counted once in Residential **AND** once in Supportive Services. Therefore, adding these two numbers may equal more than the total unduplicated number of persons served.

v Clients may self-identify up to 5 race categories; for this report, all clients self-identifying with more than one race are grouped together into the "Multiple Races" category.
