



<u>Overview – All Programs</u>


Between 1/1/2019 and 3/31/2019, providers in the FMS served 20 people experiencing or at risk of experiencing homelessness. Residential programs served 11 peopleⁱⁱ, and supportive services only (SSO) programs served 9 people. People iii




There were 9 households in the CoC, including: 4 households without children (containing 5 individuals), 5 households with children both adults and (containing 9 adults and 7 children), and 0 households of unaccompanied minors (under 18 years of age), containing 0 minors.iv

By gender, providers in the CoC served 10 (50.0%) women, 10 (50.0%) men, 0 (0) trans-identified individuals, and 0 (0) gender nonconforming individuals.

The racial breakdown of those served included: 20 (100.0%) White, 0 (0) Black or African-American, 0 (0) Asian, 0 (0) Native Hawaiian or Other Pacific Islander, 0 (0) American Indian or Alaskan Native, and 0 (0) Multiple Races. Regardless of race, 7 (35.0%) individuals identified as Hispanic/Latino in ethnicity.



Of 13 adults or heads of household, 8 (61.5%) indicated a prior residence of Emergency Shelter, the streets, or Safe Haven. Of these clients, 8 (100.0%) reported one previous episode of homelessness within the last three years. 0 (0), 0 (0), and 2 (25.0%) reported that they had been 2, 3, or 4+ times homeless (respectively) during the same time frame. 0 (0) did not report on this data element.




The total number of individuals discharged during the year was 10, which included 6 adults and 4 children. 10 (100.0%) were discharged to a permanent destination. Between admission and discharge, income for 0 (0) clients over 18 rose, while 4 (66.7%) clients over 18 maintained a stable income of greater than zero.

Sub-Populations – All Programs

0 (0) individuals over 18 met the criteria for chronic homelessness at the time of project entry. iii 1 out of every 3.0 adults receiving services this year was a veteran (33.3%). Out of the 4 veterans served, 0 (0) met the criteria for chronic homelessness at admission. At admission, 4 clients (30.8%) of all clients were considered youth (18-24 years of age.)

<u>Special Needs – HUD and HHS Funded Programs Only</u>



83.3% of adults (5/6) and 50.0% of children (1/2) in HUD or HHS funded programs self-reported at least one physical, emotional, or other health condition *regardless of whether the condition had become serious enough to be disabling*. Among those reporting multiple conditions, the most significant comorbidity was Mental Health and Substance Use (0). When taking severity of condition into account, 1 adults reported conditions that met the criteria to be considered a disability. VIII

iii For 'Persons Served' numbers only: if an individual client is served by **BOTH** Residential and Supportive Services programs within the same report period, the client is counted once in **EACH** total; therefore, adding these numbers may equal more than the total unduplicated number of persons.

iv Data based on **current** age and household composition, which may differ from information reported at admission.

Vicients may self-identify up to 5 race categories in HMIS; for this report, all clients self-identifying with more than one race are grouped together into the "Multiple Races" category.

vi HUD collects Ethnicity information under the rationale: "To indicate clients who do and do not identify themselves as Hispanic or Latino."

vii Please note that HMIS began using HUD's new definition of chronic homelessness effective 10/1/2015 and all individuals in program on or after that date are measured using this new definition, even if their program start date was prior to the change in definition taking effect.
