


# CRHMIS Quarterly Report: 2019 Q2

## NY-512 - Troy/Rensselaer County CoC

## Overview - All Programs


Between 1/1/2019 and 3/31/2019, providers in the Rensselaer CoC served 1302 people experiencing or at risk of experiencing homelessness.<sup>i</sup> Residential programs served 1087 people<sup>ii</sup>, and supportive services only (SSO) programs served 215 people.<sup>iii</sup>



There were 753 households in the CoC, including: 559 households without children (containing 577 individuals), 188 households with both adults and children (containing 250 adults and 427 children), and 6 households of only unaccompanied minors (under 18 years of age), containing 12 minors. iv


By gender, providers in the CoC served 638 (49.0%) women, 621 (47.7%) men, 7 (0.5%) trans-identified individuals, and 0 (0) gender nonconforming individuals.

The racial breakdown of those served included: 630 (48.4%) White, 533 (40.9%) Black or African-American, 5 (0.4%) Asian, 6 (0.5%) Native Hawaiian or Other Pacific Islander, 11 (0.8%) American Indian or Alaskan Native, and 47 (3.6%) Multiple Races. Regardless of race, 202 (15.5%) individuals identified as Hispanic/Latino in ethnicity.



Of 827 adults or heads of household, 455 (55.0%) indicated a prior residence of Emergency Shelter, the streets, or Safe Haven. Of these clients, 161 (35.4%) reported one previous episode of homelessness within the last three years. 84 (18.5%), 45 (9.9%), and 149 (32.7%) reported that they had been 2, 3, or 4+ times homeless (respectively) during the same time frame. 16 (3.5%) did not report on this data element.

Of the adults or heads of household who were in program a year or more and received an annual assessment (206), 120 (58.3%) saw an increase in income (cash and cash benefits) between admission and their most recent update, while 14 (6.8%) maintained a stable income of greater than zero.




The total number of individuals discharged during the year was 420, which included 293 adults and 127 children. 232 (55.2%) were discharged to a permanent destination. Between admission and discharge, income for 15 (5.1%) clients over 18 rose, while 85 (29.0%) clients over 18 maintained a stable income of greater than zero.

## **Sub-Populations – All Programs**

112 (14.1%) individuals over 18 met the criteria for chronic homelessness at the time of project entry. <sup>vii</sup> 1 out of every 17.2 adults receiving services this year was a veteran (5.8%). Out of the 46 veterans served, 30 (65.2%) reported a disabling condition and 6 (13.0%) met the criteria for chronic homelessness at admission. At admission, 96 clients (11.6%) of all clients were considered youth (18-24 years of age.)

## <u>Special Needs – HUD and HHS Funded Programs Only</u>



74.2% of adults (425/573) and 16.0% of children (68/424) in HUD or HHS funded programs self-reported at least one physical, emotional, or other health condition *regardless of whether the condition had become serious enough to be disabling*. Among those reporting multiple conditions, the most significant comorbidity was Mental Health and Substance Use (159). When taking severity of condition into account, 347 adults reported conditions that met the criteria to be considered a disability. Viii
