


NY-516 - Clinton County CoC

Overview – All Programs


Between 1/1/2019 and 3/31/2019, providers in the Clinton CoC served 541 people experiencing or at risk of experiencing homelessness.ⁱ Residential programs served 209 peopleⁱⁱ, and supportive services only (SSO) programs served 332 people.ⁱⁱⁱ



There were 366 households in the CoC, including: 312 households without children (containing 334 individuals), 52 households with both adults and children (containing 70 adults and 92 children), and 2 households of only unaccompanied minors (under 18 years of age), containing 5 minors.^{iv}


By gender, providers in the CoC served 211 (39.0%) women, 285 (52.7%) men, 2 (0.4%) transidentified individuals, and 1 (0.2%) gender non-conforming individuals.

The racial breakdown of those served included: 423 (78.2%) White, 31 (5.7%) Black or African-American, 0 (0) Asian, 1 (0.2%) Native Hawaiian or Other Pacific Islander, 5 (0.9%) American Indian or Alaskan Native, and 37 (6.8%) Multiple Races.^v Regardless of race, 30 (5.5%) individuals identified as Hispanic/Latino in ethnicity.^{vi}



Of 404 adults or heads of household, 271 (67.1%) indicated a prior residence of Emergency Shelter, the streets, or Safe Haven. Of these clients, 154 (56.8%) reported one previous episode of homelessness within the last three years. 58 (21.4%), 20 (7.4%), and 20 (7.4%) reported that they had been 2, 3, or 4+ times homeless (respectively) during the same time frame. 19 (7.0%) did not report on this data element.


Of the adults or heads of household who were in program a year or more and received an annual assessment (40), 14 (35.0%) saw an increase in income (cash and cash benefits) between admission and their most recent update, while 5 (12.5%) maintained a stable income of greater than zero.



The total number of individuals discharged during the year was 177, which included 152 adults and 25 children. 83 (46.9%) were discharged to a permanent destination. Between admission and discharge, income for 2 (1.3%) clients over 18 rose, while 52 (34.2%) clients over 18 maintained a stable income of greater than zero.

Sub-Populations – All Programs

32 (8.1%) individuals over 18 met the criteria for chronic homelessness at the time of project entry.^{vii} 1 out of every 14.1 adults receiving services this year was a veteran (7.1%). Out of the 28 veterans served, 23 (82.1%) reported a disabling condition and 3 (10.7%) met the criteria for chronic homelessness at admission. At admission, 39 clients (9.7%) of all clients were considered youth (18-24 years of age.)



Special Needs – HUD and HHS Funded Programs Only

89.2% of adults (314/352) and 36.7% of children (29/79) in HUD or HHS funded programs self-reported at least one physical, emotional, or other health condition *regardless of whether the condition had become serious enough to be disabling*. Among those reporting multiple conditions, the most significant comorbidity was Mental Health and Substance Use (162). When taking severity of condition into account, 282 adults reported conditions that met the criteria to be considered a disability.^{viii}

vii Please note that HMIS began using HUD's new definition of chronic homelessness effective 10/1/2015 and all individuals in program on or after that date are measured using this new definition, even if their program start date was prior to the change in definition taking effect.
