HUD Updates

On Wednesday, June 26th the CRHMIS team attended the quarterly HMIS System Administrator webinar hosted by HUD/TA providers titled: Deep Dive for new Data Standards.

The bulk of the webinar was about the new Coordinated Entry elements that will be added and released on 10/1.

Street Outreach Projects had to record every "Contact" had with a client in an HMIS using specific contact fields in the Intake/Admission record. Effective 10/1, Street Outreach and Coordinated Entry Projects will have to record every "Contact" had with a client.

We are not entirely sure yet just what this will look like within

AWARDS, so please keep an eye out for updates. Our hope is to hold community level training sessions to ensure all Coordinated Entry participants understand how and when events will be recorded in HMIS and who is responsible for the data entry.











RHY Updates

The FY2019 PATH ARS report was released in early June. A new Housing Outcomes question was added, a few outdated questions were removed, and the remaining questions were renumbered and updated to use the current (FY2017) data standards.
