


# CRHMIS Quarterly Report: 2019 Q3

# NY-520 - Franklin & Essex Counties CoC

### Overview - All Programs

Between 4/1/2019 and 6/30/2019, providers in the Franklin-Essex CoC served 119 people experiencing or at risk of experiencing homelessness.<sup>i</sup> Residential programs served 119 individuals a total of 122 times, and supportive services-only programs served 0 individuals.<sup>ii, iii</sup>




There were 92 households in the CoC, including: 78 households without children (containing 80 individuals), 14 households with both adults and children (containing 18 adults and 22 children), and 0 households of only unaccompanied minors (under 18 years of age). iv


By gender, providers in the CoC served 42 (35.3%) women, 75 (63.0%) men, 2 (1.7%) transidentified individuals, and 0 gender non-conforming individuals.

The racial breakdown of those served included: 100 (84.0%) White, 2 (1.7%) Black or African-American, 1 (0.8%) Asian, 0 Native Hawaiian or Other Pacific Islander, 6 (5.0%) American Indian or Alaskan Native, and 6 (5.0%) Multiple Races. Regardless of race, 3 (2.5%) individuals identified as Hispanic/Latino in ethnicity.

Of 97 adults or heads of household, 42 (43.3%) indicated a prior residence of Emergency Shelter, the streets, or Safe Haven. Of these clients, 20 (47.6%) reported one previous episode of homelessness within the last three years. 5 (11.9%), 4 (9.5%), and 4 (9.5%) reported that they had been 2, 3, or 4+ times homeless (respectively) during the same time frame. 9 (21.4%) did not report on this data element.



Of the adults or heads of household who were in program a year or more and received an annual assessment (8), 3 (37.5%) saw an increase in income (cash and cash benefits) between admission and their most recent update, while 2 (25.0%) maintained a stable income of greater than zero.




The total number of individuals discharged during the year was 27, which included 27 adults and 0 children. 13 (48.1%) were discharged to a permanent destination. Between admission and discharge, 4 (14.8%) clients over 18 maintained a stable income of greater than zero.

## <u>Sub-Populations – All Programs</u>

1 (1.1%) individuals over 18 met the criteria for chronic homelessness at the time of project entry. <sup>vii</sup> 1 out of every 9.3 adults receiving services this year was a veteran (10.8%). Out of the 10 veterans served, 6 (60.0%) reported a disabling condition and 0 met the criteria for chronic homelessness at admission. At admission, 11 clients (11.3%) of all clients were considered youth (18-24 years of age.)

# Special Needs – HUD and HHS Funded Programs Only



73.0% of adults (27/37) and 14.3% of children (3/21) in HUD or HHS funded programs self-reported at least one physical, emotional, or other health condition *regardless of whether the condition had become serious enough to be disabling*. Among those reporting multiple conditions, the most significant comorbidity was Mental Health and Substance Use (9). When taking severity of condition into account, 18 adults reported conditions that met the criteria to be considered a disability. VIII
