

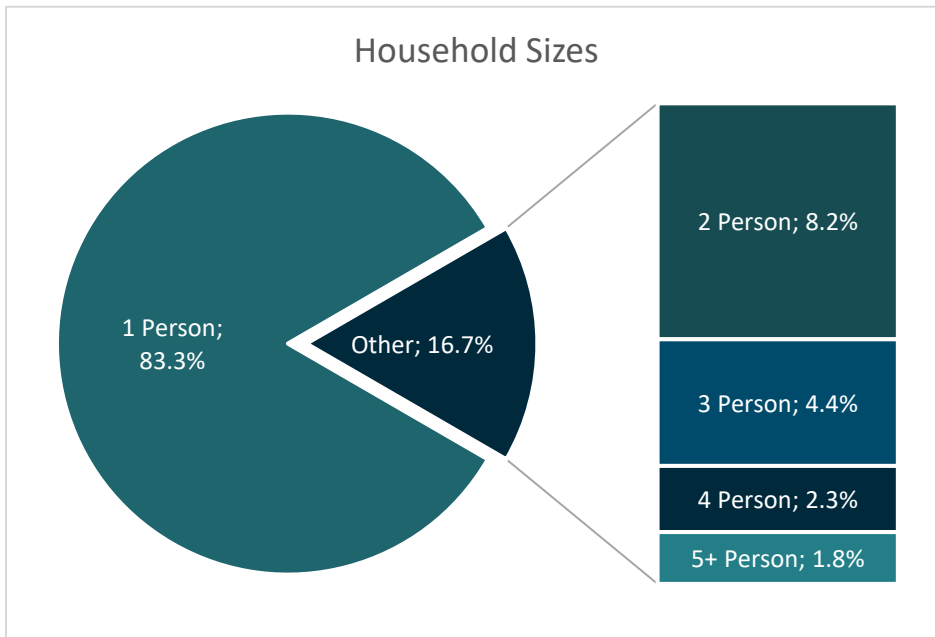
CRHMIS Quarterly Report: 2019 Q3

NY-523 - Glen Falls, Saratoga Springs/Saratoga, Washington, Warren, & Hamilton Counties CoC

Overview – All Programs

Between 4/1/2019 and 6/30/2019, providers in the Saratoga CoC served 514 people experiencing or at risk of experiencing homelessness.ⁱ Residential programs served 466 individuals a total of 530 times, and supportive services-only programs served 48 individuals a total of 48 times.^{ii, iii}

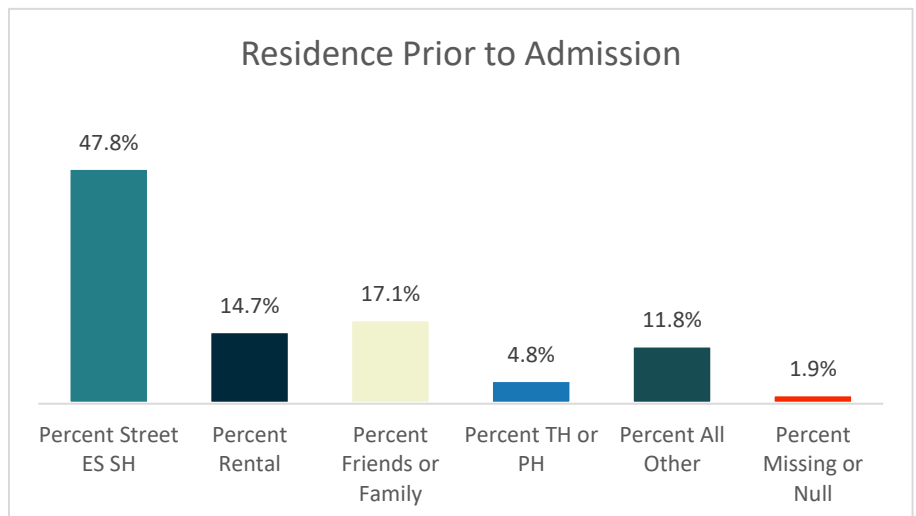


There were 389 households in the CoC, including: 310 households without children (containing 323 individuals), 52 households with both adults and children (containing 69 adults and 93 children), and 27 households of only unaccompanied minors (under 18 years of age), containing 27 minors.^{iv}

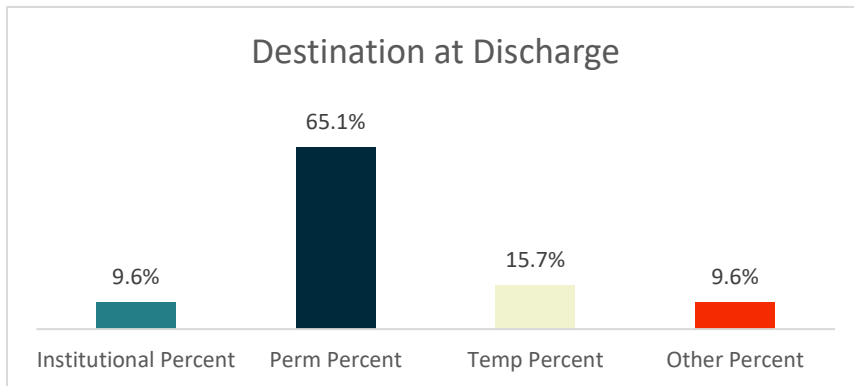
By gender, providers in the CoC served 193 (37.5%) women, 316 (61.5%) men, 3 (0.6%) trans-identified individuals, and 0 gender non-conforming individuals.

The racial breakdown of those served included: 405 (78.8%) White, 84 (16.3%) Black or African-American, 0 Asian, 0 Native Hawaiian or Other Pacific Islander, 1 (0.2%) American Indian or Alaskan Native, and 16 (3.1%) Multiple Races.^v Regardless of race, 30 (5.8%) individuals identified as Hispanic/Latino in ethnicity.^{vi}

Of 416 adults or heads of household, 199 (47.8%) indicated a prior residence of Emergency Shelter, the streets, or Safe Haven. Of these clients, 88 (44.2%) reported one previous episode of homelessness within the last three years. 28 (14.1%), 18 (9.0%), and 46 (23.1%) reported that they had been 2, 3, or 4+ times homeless (respectively) during the same time frame. 20 (10.1%) did not report on this data element.



Of the adults or heads of household who were in program a year or more and received an annual assessment (103), 41 (39.8%) saw an increase in income (cash and cash benefits) between admission and their most recent update, while 24 (23.3%) maintained a stable income of greater than zero.

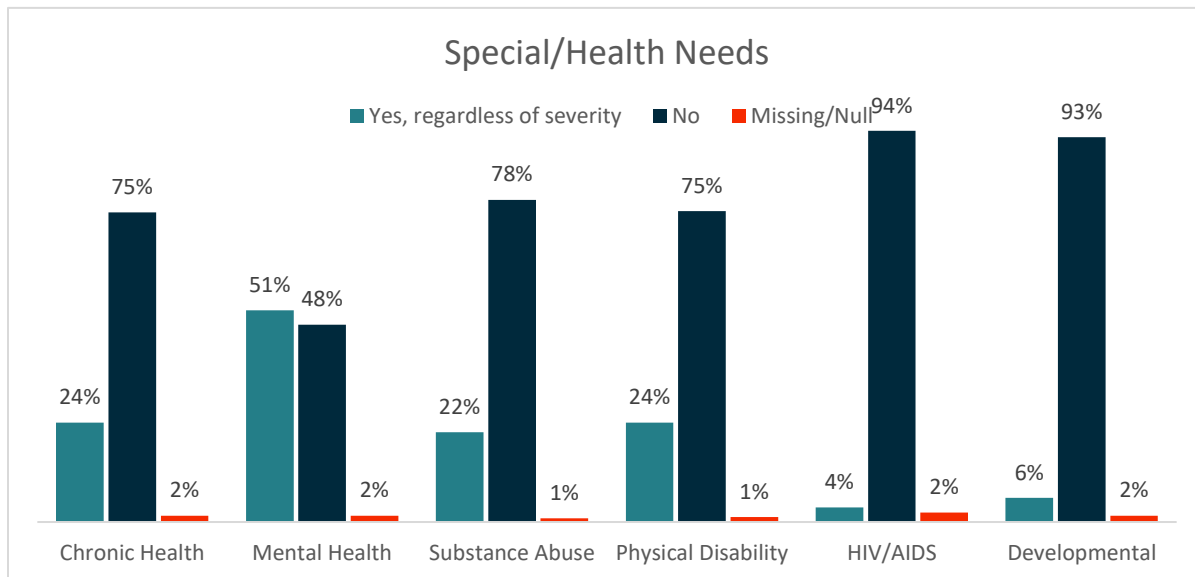


The total number of individuals discharged during the year was 166, which included 125 adults and 41 children. 108 (65.1%) were discharged to a permanent destination. Between admission and discharge, income for 8 (6.4%) clients over 18 rose, while 60 (48.0%) clients over 18 maintained a stable income of greater than zero.

Sub-Populations – All Programs

36 (9.6%) individuals over 18 met the criteria for chronic homelessness at the time of project entry.^{vii} 1 out of every 2.8 adults receiving services this year was a veteran (36.3%). Out of the 136 veterans served, 98 (72.1%) reported a disabling condition and 19 (14.0%) met the criteria for chronic homelessness at admission. At admission, 56 clients (14.3%) of all clients were considered youth (18-24 years of age.)

Special Needs – HUD and HHS Funded Programs Only



79.8% of adults (193/242) and 27.7% of children (28/101) in HUD or HHS funded programs self-reported at least one physical, emotional, or other health condition *regardless of whether the condition had become serious enough to be disabling*. Among those reporting multiple conditions, the most significant comorbidity was Mental Health and Substance Use (59). When taking severity of condition into account, 152 adults reported conditions that met the criteria to be considered a disability.^{viii}

ⁱⁱ For this report, all Permanent Housing (Housing Only, Housing with Services, Permanent Supportive Housing, and Rapid Re-Housing) and Transitional Housing are residential; Street Outreach, Homelessness Prevention, Day Shelter, and Services Only Program enrollments are Supportive Services.

ⁱⁱⁱ "Persons Served" totals only: if an individual client is served by **BOTH** Residential and Supportive Services within the same report period, the client is counted once in **EACH** total; therefore, adding these together may equal more than the total unduplicated number of persons served. Only new enrollments for the quarter are included for Supportive Services.
