



# Overview - All Programs


Between 4/1/2019 and 6/30/2019, providers in the Rockland CoC served 258 people experiencing or at risk of experiencing homelessness.<sup>i</sup> Residential programs served 258 individuals a total of 300 times, and supportive services-only programs served 0 individuals.<sup>ii, iii</sup>



There were 188 households in the CoC, including: 155 households without children (containing 159 individuals), 30 households with both adults and children (containing 41 adults and 52 children), and 3 households of only unaccompanied minors (under 18 years of age), containing 6 minors. iv


By gender, providers in the CoC served 99 (38.4%) women, 156 (60.5%) men, 0 trans-identified individuals, and 0 gender nonconforming individuals.

The racial breakdown of those served included: 103 (39.9%) White, 119 (46.1%) Black or African-American, 3 (1.2%) Asian, 1 (0.4%) Native Hawaiian or Other Pacific Islander, 3 (1.2%) American Indian or Alaskan Native, and 6 (2.3%) Multiple Races. Regardless of race, 60 (23.3%) individuals identified as Hispanic/Latino in ethnicity. Hispanic Pacific Islander, 3 (1.2%) American Indian or Alaskan Native, and 6 (2.3%) Multiple Races. Of 200 adults or heads of household, 70 (35.0%) indicated a prior residence of Emergency Shelter, the streets, or Safe Haven. Of these clients, 24 (34.3%) reported one previous episode of homelessness within the last three years. 7 (10.0%), 8 (11.4%), and 21 (30.0%) reported that they had been 2, 3, or 4+ times homeless (respectively) during the same time frame. 10 (14.3%) did not report on this data element.

Of the adults or heads of household who were in program a year or more and received an annual assessment (11), 4 (36.4%) saw an increase in income (cash and cash benefits) between admission and their most recent update, while 4 (36.4%) maintained a stable income of greater than zero.




The total number of individuals discharged during the year was 23, which included 18 adults and 5 children. 18 (78.3%) were discharged to a permanent destination. Between admission and discharge, 3 (16.7%) clients over 18 maintained a stable income of greater than zero.

# **Sub-Populations – All Programs**

29 (14.7%) individuals over 18 met the criteria for chronic homelessness at the time of project entry. <sup>vii</sup> 1 out of every 10.9 adults receiving services this year was a veteran (9.1%). Out of the 18 veterans served, 12 (66.7%) reported a disabling condition and 2 (11.1%) met the criteria for chronic homelessness at admission. At admission, 15 clients (7.5%) of all clients were considered youth (18-24 years of age.)

## Special Needs - HUD and HHS Funded Programs Only



63.2% of adults (72/114) and 18.5% of children (5/27) in HUD or HHS funded programs self-reported at least one physical, emotional, or other health condition *regardless of whether the condition had become serious enough to be disabling*. Among those reporting multiple conditions, the most significant comorbidity was Mental Health and Substance Use (13). When taking severity of condition into account, 53 adults reported conditions that met the criteria to be considered a disability. VIII

For this report, all Permanent Housing (Housing Only, Housing with Services, Permanent Supportive Housing, and Rapid Re-Housing) and Transitional Housing are residential; Street Outreach, Homelessness Prevention, Day Shelter, and Services Only Program enrollments are Supportive Services.

<sup>&</sup>quot;"Persons Served" totals only: if an individual client is served by **BOTH** Residential and Supportive Services within the same report period, the client is counted once in **EACH** total; therefore, adding these together may equal more than the total unduplicated number of persons served. Only new enrollments for the quarter are included for Supportive Services.
