


CRHMIS Quarterly Report: 2019 Q3

NY-608 - Kingston/Ulster County CoC

Overview - All Programs

Between 4/1/2019 and 6/30/2019, providers in the Ulster CoC served 740 people experiencing or at risk of experiencing homelessness.ⁱ Residential programs served 740 individuals a total of 899 times, and supportive services-only programs served 0 individuals.^{ii, iii}




There were 433 households in the CoC, including: 261 households without children (containing 267 individuals), 139 households with both adults and children (containing 186 adults and 254 children), and 33 households of only unaccompanied minors (under 18 years of age), containing 33 minors.^{iv}


By gender, providers in the CoC served 366 (49.5%) women, 370 (50.0%) men, 4 (0.5%) trans-identified individuals, and 0 gender non-conforming individuals.

The racial breakdown of those served included: 491 (66.4%) White, 196 (26.5%) Black or African-American, 1 (0.1%) Asian, 3 (0.4%) Native Hawaiian or Other Pacific Islander, 7 (0.9%) American Indian or Alaskan Native, and 40 (5.4%) Multiple Races. Regardless of race, 123 (16.6%) individuals identified as Hispanic/Latino in ethnicity.

Of 479 adults or heads of household, 142 (29.6%) indicated a prior residence of Emergency Shelter, the streets, or Safe Haven. Of these clients, 63 (44.4%) reported one previous episode of homelessness within the last three years. 19 (13.4%), 22 (15.5%), and 38 (26.8%) reported that they had been 2, 3, or 4+ times homeless (respectively) during the same time frame. 0 did not report on this data element.



Of the adults or heads of household who were in program a year or more and received an annual assessment (46), 18 (39.1%) saw an increase in income (cash and cash benefits) between admission and their most recent update, while 14 (30.4%) maintained a stable income of greater than zero.




The total number of individuals discharged during the year was 303, which included 188 adults and 115 children. 146 (48.2%) were discharged to a permanent destination. Between admission and discharge, income for 12 (6.4%) clients over 18 rose, while 56 (29.8%) clients over 18 maintained a stable income of greater than zero.

Sub-Populations – All Programs

35 (8.1%) individuals over 18 met the criteria for chronic homelessness at the time of project entry. ^{vii} 1 out of every 20.5 adults receiving services this year was a veteran (4.9%). Out of the 21 veterans served, 17 (81.0%) reported a disabling condition and 2 (9.5%) met the criteria for chronic homelessness at admission. At admission, 82 clients (18.1%) of all clients were considered youth (18-24 years of age.)

<u>Special Needs – HUD and HHS Funded Programs Only</u>



70.8% of adults (320/452) and 10.8% of children (31/287) in HUD or HHS funded programs self-reported at least one physical, emotional, or other health condition *regardless of whether the condition had become serious enough to be disabling*. Among those reporting multiple conditions, the most significant comorbidity was Mental Health and Substance Use (97). When taking severity of condition into account, 237 adults reported conditions that met the criteria to be considered a disability. Viii

Only new enrollments for the quarter are included for Supportive Services.
