


# CRHMIS Quarterly Report: 2019 Q4

## **NY-516 - Clinton County CoC**

### <u>Overview – All Programs</u>


Between 7/1/2019 and 9/30/2019, providers in the Clinton CoC served 494 people experiencing or at risk of experiencing homelessness.<sup>i</sup> Residential programs served 175 individuals a total of 178 times, and supportive services only programs served 319 individuals a total of 320 times.<sup>ii, iii</sup>



There were 341 households in the CoC, including: 294 households without children (containing 302 individuals), 44 households with both adults and children (containing 59 adults and 85 children), and 3 households of only unaccompanied minors (under 18 years of age), containing 3 minors. iv

By gender, providers in the CoC served 195 (39.5%) women, 250 (50.6%) men, 2 (0.4%) trans-identified individuals, and 0 () gender nonconforming individuals.

The racial breakdown of those served included: 366 (74.1%) White, 43 (8.7%) Black or African-American, 0 () Asian, 1 (0.2%) Native Hawaiian or Other Pacific Islander, 2 (0.4%) American Indian or Alaskan Native, and 32 (6.5%) Multiple Races. Regardless of race, 33 (6.7%) individuals identified as Hispanic/Latino in ethnicity.



Of 362 adults or heads of household, 245 (67.7%) indicated a prior residence of Emergency Shelter, the streets, or Safe Haven. Of these clients, 132 (53.9%) reported one previous episode of homelessness within the last three years. 64 (26.1%), 18 (7.3%), and 20 (8.2%) reported that they had been 2, 3, or 4+ times homeless (respectively) during the same time frame. 11 (4.5%) did not report on this data element.


Of the adults or heads of household who were in program a year or more and received an annual assessment (43), 15 (34.9%) saw an increase in income (cash and cash benefits) between admission and their most recent update, while 8 (18.6%) maintained a stable income of greater than zero.

The total number of individuals discharged during the year was 139, which included 110 adults and 29 children. 54 (38.8%) were discharged to a permanent destination. Between admission and discharge, income for 6 (5.5%) clients over 18 rose, while 35 (31.8%) clients over 18 maintained a stable income of greater than zero.

## <u>Sub-Populations – All Programs</u>

32 (8.9%) individuals over 18 met the criteria for chronic homelessness at the time of project entry. ii 1 out of every 14.9 adults receiving services this year was a veteran (6.7%). Out of the 24 veterans served, 20 (83.3%) reported a disabling condition and 4 (16.7%) met the criteria for chronic homelessness at admission. At admission, 34 clients (9.4%) of all clients were considered youth (18-24 years of age.)

## Special Needs – HUD and HHS Funded Programs Only



93.5% of adults (274/293) and 43.3% of children (29/67) in HUD or HHS funded programs self-reported at least one physical, emotional, or other health condition *regardless of whether the condition had become serious enough to be disabling*. Among those reporting multiple conditions, the most significant comorbidity was Mental Health and Substance Use (153). When taking severity of condition into account, 261 adults reported conditions that met the criteria to be considered a disability. Viii

Only new enrollments for the quarter are included for Supportive Services.
