


# NY-516 - Clinton County CoC

#### **Overview – All Programs**


Between 10/1/2018 and 9/30/2019, providers in the Clinton CoC served 1127 people experiencing or at risk of experiencing homelessness.<sup>i</sup> Residential programs served 333 individuals a total of 351 times, and supportive services only programs served 794 individuals a total of 846 times.<sup>ii, iii</sup>



There were 716 households in the CoC, including: 592 households without children (containing 632 individuals), 121 households with both adults and children (containing 171 adults and 224 children), and 3 households of only unaccompanied minors (under 18 years of age), containing 3 minors.<sup>iv</sup>

By gender, providers in the CoC served 455 (40.4%) women, 566 (50.2%) men, 5 (0.4%) trans-identified individuals, and 1 (0.1%) gender non-conforming individuals.


The racial breakdown of those served included: 850 (75.4%) White, 83 (7.4%) Black or African-American, 2 (0.2%) Native Hawaiian or Other Pacific Islander, 12 (1.1%) American Indian or Alaskan Native, and 75 (6.7%) Multiple Races.<sup>v</sup> Regardless of race, 69 (6.1%) individuals identified as Hispanic/Latino in ethnicity.<sup>vi</sup>



Of 804 adults or heads of household, 548 (68.2%) indicated a prior residence of Emergency Shelter, the streets, or Safe Haven. Of these clients, 341 (62.2%) reported one previous episode of homelessness within the last three years. 111 (20.3%), 35 (6.4%), and 39 (7.1%) reported that they had been 2, 3, or 4+ times homeless (respectively) during the same time frame. 22 (4.0%) did not report on this data element.

Of the adults or heads of household who were in program a year or more and received an annual assessment (52), 17 (32.7%) saw an increase in income (cash and cash benefits) between admission and their most recent update, while 10 (19.2%) maintained a stable income of greater than zero.



The total number of individuals discharged during the year was 739, which included 571 adults and 168 children. 399 (54.0%) were discharged to a permanent destination. Between admission and discharge, income for 13 (2.3%) clients over 18 rose, while 251 (44.0%) clients over 18 maintained a stable income of greater than zero.

### Sub-Populations – All Programs

57 (7.3%) individuals over 18 met the criteria for chronic homelessness at the time of project entry.<sup>vii</sup> 1 out of every 16.3 adults receiving services this year was a veteran (6.1%). Out of the 48 veterans served, 38 (79.2%) reported a disabling condition and 5 (10.4%) met the criteria for chronic homelessness at admission. At admission, 89 clients (11.1%) of all clients were considered youth (18-24 years of age.)



## Special Needs – HUD and HHS Funded Programs Only

87.6% of adults (634/724) and 36.1% of children (73/202) in HUD or HHS funded programs self-reported at least one physical, emotional, or other health condition *regardless of whether the condition had become serious enough to be disabling*. Among those reporting multiple conditions, the most significant comorbidity was Mental Health and Substance Use (295). When taking severity of condition into account, 565 adults reported conditions that met the criteria to be considered a disability.<sup>viii</sup>
