


CRHMIS Quarterly Report: 2019 Q4

Overview – All Programs


Between 7/1/2019 and 9/30/2019, providers in the Columbia-Greene CoC served 190 people experiencing or at risk of experiencing homelessness.ⁱ Residential programs served 176 individuals a total of 177 times, and supportive services-only programs served 14 individuals a total of 14 times.^{ii, iii}



There were 118 households in the CoC, including: 92 households without children (containing 102 individuals), 25 households with both adults and children (containing 36 adults and 50 children), and 1 households of only unaccompanied minors (under 18 years of age), containing 1 minor. iv

By gender, providers in the CoC served 85 (44.7%) women, 103 (54.2%) men, 1 (0.5%) transidentified individuals, and 0 () gender non-conforming individuals.


The racial breakdown of those served included: 126 (66.3%) White, 33 (17.4%) Black or African-American, 0 () Asian, 0 () Native Hawaiian or Other Pacific Islander, 0 () American Indian or Alaskan Native, and 20 (10.5%) Multiple Races. Regardless of race, 22 (11.6%) individuals identified as Hispanic/Latino in ethnicity. In the racial breakdown of those served included: 126 (66.3%) White, 33 (17.4%) Black or African-American, 0 () Asian, 0 () Native Hawaiian or Other Pacific Islander, 0 () American Indian or Alaskan Native, and 20 (10.5%) Multiple Races. Of 138 adults or heads of household, 56 (40.6%) indicated a prior residence of Emergency Shelter, the streets, or Safe Haven. Of these clients, 21 (37.5%) reported one previous episode of homelessness within the last three years. 2 (3.6%), 5 (8.9%), and 19 (33.9%) reported that they had been 2, 3, or 4+ times homeless (respectively) during the same time frame. 9 (16.1%) did not report on this data element.

Of the adults or heads of household who were in program a year or more

and received an annual assessment (23), 10 (43.5%) saw an increase in income (cash and cash benefits) between admission and their most recent update, while 0 () maintained a stable income of greater than zero.




The total number of individuals discharged during the year was 19, which included 16 adults and 3 children. 4 (21.1%) were discharged to a permanent destination. Between admission and discharge, income for 0 () clients over 18 rose, while 6 (37.5%) clients over 18 maintained a stable income of greater than zero.

<u>Sub-Populations – All Programs</u>

20 (14.8%) individuals over 18 met the criteria for chronic homelessness at the time of project entry. ^{vii} 1 out of every 19.3 adults receiving services this year was a veteran (5.2%). Out of the 7 veterans served, 6 (85.7%) reported a disabling condition and 2 (28.6%) met the criteria for chronic homelessness at admission. At admission, 9 clients (6.5%) of all clients were considered youth (18-24 years of age.)

<u>Special Needs – HUD and HHS Funded Programs Only</u>



80.0% of adults (60/75) and 30.0% of children (9/30) in HUD or HHS funded programs self-reported at least one physical, emotional, or other health condition *regardless of whether the condition had become serious enough to be disabling*. Among those reporting multiple conditions, the most significant comorbidity was Mental Health and Substance Use (19). When taking severity of condition into account, 50 adults reported conditions that met the criteria to be considered a disability. viii

[&]quot;"Persons Served" totals only: if an individual client is served by **BOTH** Residential and Supportive Services within the same report period, the client is counted once in **EACH** total; therefore, adding these together may equal more than the total unduplicated number of persons served. Only new enrollments for the quarter are included for Supportive Services.
