

Updates



CCHMIS Updates

- Effective July 1st we officially transitioned from being the CARES Regional HMIS to the CARES Collaborative HMIS. We are currently working on updating all documentation to reflect this change.
- 2. The HMIS System Administrator calls that we participate in with HUD and National TA providers have largely revolved around Project Set Up and Reporting Requirements for ESG-CV funding. We will send out the requirements once we receive final guidance from HUD.
 - The current expectation is that there will be no extra HMIS data collection required by projects that recieve funding.
- Coordinated Entry Projects that receive CoC funding are still expected to be implemented into HMIS by October



- 4. There will be no changes or updates to the HMIS Data Standards in October for data collection. All of the updates are specific to the HMIS System Administrators surrounding Project Descriptor Data Elements.
- The LSA's (Longitudnal System Analysis) have been pushed back from a mid-July opening to opening in October.
- If you haven't visited our <u>website</u> yet, I would highly recommend checking it out. Travis Brodbeck has done a wonderful job of updating it to make it more user friendly.

RHY Updates

On our most recent HMIS System Administrator call in July we learned that there will be 2 HMIS Data Upload submissions to the RHYPoint Portal this fall. Grantees who have grants that expire on 9/30/2020 will upload their data during the month of September, while Grantees who do not have grants expiring on 9/30/2020 will upload their data in October. I will begin pulling Grantees' HMIS data and reaching out in August to review for any validation errors and/or data correction that may be neccessary for a successful upload.
