



The rapid rehousing component will serve an additional 6 households and will be operated as scattered site housing. The target population for this program is survivors of domestic violence or sexual assault, with a special focus on those who are chronically homeless. The project will operate using a housing-first approach, and case management will be available to assist clients to work on their individual goals.
