Subject: Housing Inventory and Point-in-Time Count Summary

Memo Overview and Intention

This memorandum summarizes highlights from the 2023 Housing Inventory Chart (HIC) and Point-in-Time Count (PIT) compared to 2022 data.

2023 Housing Inventory Summary

Continuums are required to annually report the number of available beds dedicated to homeless persons; these include emergency, safe haven, transitional and permanent housing beds. Below is a summary of changes from 2022 to 2023. Under each section, you will see a breakdown of the *primary* reasons contributing to the change.

Emergency Housing:

- Emergency Year-Round Beds: The number of emergency year-round beds decreased by 19, from 103 in 2022 to 84 in 2023.
 - *Interfaith Partnership for the Homeless Medical Respite* moved its physical location to Albany County accounting for a 17 bed decrease
- o *Emergency Overflow Beds:* The number of overflow beds increased from 13 beds in 2022 to 16 beds in 2023, with the addition of 3 persons served by Rensselaer County DSS in hotels/motels on the night of the count.
- o *Emergency Seasonal Beds:* The number of seasonal beds remained the same at o beds.
- **Transitional Beds:** The number of transitional beds increased by 12, from 27 in 2022 to 39 in 2023 due to family composition.
 - o Unity House UH 374 increased from 9 beds in 2022 to 14 in 2023.
 - o YWCA GCR Women in Transition increased from 16 beds in 2022 to 23 beds in 2023.

Permanent Housing Beds:

- Permanent Supportive Housing: Permanent supportive housing beds increased by 33, from 662 in 2022 to 695 in 2022, due to utilization and/or family composition and new projects being added to the HIC.
 - **St. Paul's Center Lee Dyer Family Apartments** decreased from 34 to 27 beds due to family composition.
 - *Joseph's House Bethune Program* decreased by 10, from 43 in 2022 to 33 in 2023 due to utilization.



- *Unity House of Troy Permanent Supported Housing Program 800* decreased by 4, from 143 in 2022 to 139 in 2023 due to family composition (???).
- Unity House of Troy UH 300 increased by 51, from 84 in 2022 to 135 in 2023 due to utilization.
- *Veterans Administration VASH VA* decreased by 9, from 18 in 2022 to 9 in 2023.
- o *Rapid Rehousing*: The Rapid Rehousing bed count increased by 20 beds, from 132 in 2022 to 152 in 2023 (15% increase).
 - Joseph's House JH NYS ESG-CV RRH closed due to exhausting funding for a loss of 19 beds.
 - *St. Paul's* Cabrini Health RRH increased from 5 to 6 beds.
 - St. Paul's ESG-CV RRH decreased from 15 beds to 3 due to utilization.
 - *St. Paul's* St. Paul NYS ESG-CV RRH increased by 32 beds, from 7 in 2022 to 39 in 2023 due to utilization.
 - *Unity House of Troy STEHP Rapid Rehousing* increased by 23 beds, from 19 in 2022 to 42 in 2023 due to increased utilization.
 - *Unity House of Troy Supportive Housing (352)* increased by 12 beds, from 8 beds in 2022 to 20 beds in 2023 due to increased utilization.
 - Unity House of Troy UH ESG-CV RRH closed due to exhausting funding with a loss of 8 beds.
 - Unity House of Troy UH NYS ESG-CV RRH closed due to exhausting funding with a loss of 10 beds.
 - **St. Catherine's Center for Children** Project Host decreased by 2 beds, from 8 beds in 2022 to 6 in 2023.
- O **Dedicated Chronic Homeless Beds:** the number of dedicated chronic homeless beds decreased from 259 in 2022 to 244 in 2023 due to utilization.

NOTE: a lack of a 20% increase in the number of Rapid Rehousing beds on the HIC may negatively impact the CoC's Application score in FY2023.

Sheltered PIT Breakdown



- When comparing the 2023 (133 persons) sheltered PIT with the 2022 (134 persons) sheltered PIT, a decrease in the total number of persons sheltered is noted.
- In total, there was a decrease of 1 person utilizing services on the night of the count with a 6-person decrease in the use of Emergency Shelters and a 5-person increase in use of transitional services.

Sheltered PIT Subpopulation Information

- *Chronically Homeless Individuals:* The number of sheltered chronically homeless individuals decreased by 4, from 6 in 2022 to 2 in 2023.
- *Chronically Homeless Families*: The number of sheltered chronically homeless households remained at o.
- Chronically Homeless Vets: The number of sheltered chronically homeless veterans remained at o.
- Chronically Homeless Youth: The number of sheltered chronically homeless youth remained at 1.
- *Adults with a Serious Mental Illness:* The number of sheltered persons with serious mental illness decreased from 34 in 2022 to 20 in 2023.
- *Adults with a Substance Use Disorder*: The number of sheltered persons with substance abuse disorders decreased from 18 in 2022 to 7 in 2023.
- Adults with HIV/AIDS: The number of sheltered persons with HIV/AIDS remained at o.
- *Victims of Domestic Violence*: The number of sheltered persons noting DV decreased from 38 in 2022 to 25 in 2023.

NOTE: Special populations (e.g., persons living with HIV/AIDS) often do not disclose their status which may indicate a lower than actual total number reported.

Unsheltered PIT breakdown

- When comparing the 2022 unsheltered PIT with the 2023 unsheltered PIT, a 9-person increase was noted was noted.
- In 2022 there were 14 unsheltered individuals identified compared to 23 in 2023.

Unsheltered PIT Subpopulation Information

- *Chronically Homeless Individuals*: The number of unsheltered chronically homeless individuals increased from 10 in 2022 to 16 in 2023.
- *Chronically Homeless Families*: The number of unsheltered chronically homeless families remained at zero.
- *Chronically Homeless Vets*: The number of unsheltered chronically homeless veterans increased from 0 in 2022 to 1 in 2023.
- *Adults with a Serious Mental Illness*: The number of unsheltered persons noting a serious mental illness increased from 10 in 2022 to 17 in 2023.
- *Adults with a Substance Use Disorder*: The number of unsheltered persons noting a substance use disorder increased from 6 in 2022 to 16 in 2023.
- *Adults with HIV/AIDS*: The number of unsheltered persons noting HIV/AIDS increased from 0 in 2022 to 1 in 2023.
- *Victims of Domestic Violence*: The number of unsheltered persons noting DV increased from 0 in 2022 to 3 in 2023.
