READING THIS REPORT:



- The LSA includes the following HMIS Project Types:
 - EST- Emergency Shelter and Transitional Housing
 - Emergency Shelter (ES) includes any facility with overnight sleeping accommodations, the primary purpose of which is to provide temporary shelter for the homeless in general or for specific populations of the homeless.
 - <u>Transitional Housing (TH)</u> provides temporary housing with supportive services to individuals and families experiencing homelessness with the goal of interim stability and support to successfully move to and maintain permanent housing.
 - RRH- Rapid Re-Housing
 - Rapid Re-Housing (RRH) is permanent housing that provides short-term (up to three months) and medium-term (4-24 months) tenant-based rental assistance and supportive services to households experiencing homelessness.
 - PSH- Permanent Supportive Housing
 - <u>Permanent Supportive Housing (PSH)</u> is permanent housing in which housing assistance (e.g., long-term leasing or rental assistance) and supportive services are provided to assist households with at least one member (adult or child) with a disability in achieving housing stability
 - SH- Safe Haven
 - <u>Safe Haven (SH)</u>, as defined in the Supportive Housing Program, is a form of supportive housing that serves hard-to-reach homeless persons with severe mental illness who come primarily from the streets and have been unable or unwilling to participate in housing or supportive services.
- New categorization of Household Types have been included in the LSA:
 - AO- Adult Only (Includes any household where all members are age 18 or older)
 - AC- Adult and Child (Includes any household of at least one person ages 18 or older, and at least one person under 18)
 - CO- Child Only Includes any household where all members are age 17 or younger)
- Additional Terms:
 - HH- Household
 - HoH- Head of Household
 - CRP- Current Report Period

SECTION 1: GENERAL OVERVIEW



1A. NY-503 SYSTEM PERFORMANCE OVERVIEW

The NY-503 Albany City and County CoC LSA is generated from the data entered in the CARES Collaborative HMIS (CCHMIS) by the Continuum's Contributing Homeless Organizations (CHO).

Because this CoC does not have 100% HMIS participation from Homeless Services Providers (other than providers that are *prohibited from HMIS participation) this report is not 100% reflective of the community.

The data in this report was captured by Stella. Stella is an assessment and analysis tool that assists CoCs in understanding how their systems perform. It also provides visual aids that makes data digestible which assists in addressing homelessness within a geographic area.






1D. AVERAGE DAYS HOMELESS





In the 2021-2022 FY, there were a total of 1,052 households exited the homeless system.

Of the total households:

- 280 households exited to a permanent destination
- 180 households were adult only
- 97 households were adult & child
- 3 households were child only




2B. EXITS BY DESTINATION TYPE



Key Takeaways:

- In 2020: of the 1203 Households, 323 exited to permanent destinations
- In 2021: of the 884 Households, 202 exited to permanent destinations
- In 2022: of the 1052 Households, 280 exited to permanent destinations
- The overall trendline for all three (3) years concludes that just under 30% of all households exit to a permanent destination



2D. EXITS TO PERMANENT DESTINATIONS VS. RETURNS




Exits vs Returns:

- Within the first 6 months of the Current Report Period (CRP), there was a 7% return rate.
- Within the 12 months period prior to the CRP, there was a 9% return rate.
- Between 12 months and 24 months prior to CRP, there was an 8% return rate.

Despite the length of time, there is less than 10% return rates across all project types within the NY-503 CoC.

There were:

- 89 HH served within the first 6mos
- 202 HH served within the 12mos prior to CRP
- 323 HH served between 12mos and 24mos prior to CRP










2E. TIME DISTRIBUTION OF RETURNS

- > Though there is a steady return to homelessness within and in between the twelve months to twenty-four months prior to the CRP, there is a decline in returns to homelessness within the first six months of the CRP for Adult Only households.
- Adult and Child households also saw no returns in the first six months of the CRP.

Percent of households that returned to the homeless system within 6, 12, and 24 months after exiting to a permanent destination.











Veteran Status of Adults Per Program











Gender of HoH and Adults in Adult Only Households

















 - Permanent Supportive Housing:
 - 82% of participants in PSH were living in homeless situations (sheltered or street) prior.
 - Rapid Re-Housing:
 - 76% of RRH participants were living in homeless situations (sheltered or street) prior.














