Increase in undocumented

The reasons that best explain the change (a net increase of 44 persons) in the sheltered count from last year\\\'s count are: (1) Change in Availability of Affordable Housing; (2) Change in capacity due to COVID 19; and Increase in Warming Center Capacity.

Change in Availability of Affordable Housing: CoC's area has seen an extremely low vacancy rate and a stark decline in available affordable housing. As a result, more households have been staying in shelter – even if voucher assistance is available – it has been challenging to find available units.

Change in Capacity due to COVID 19: shelters that had reduced capacity due to COVID restrictions are now operating at full capacity. The PIT for the DSS Family Shelter was 8 in 2022 and increased to 29 in 2023, as more families are seeking shelter due to lifting of moratorium

.The warming center has seen a sharp increase in undocumented persons utilizing the warming center as they have limited shelter options.

The CoC conducted outreach to all volunteers late in 2022. In addition to the PIT lead Training, volunteers were trained virtually which increased the number that participated. Additionally, PIT leads hosted weekly planning meetings focused on both canvassing and site based events.

The reasons that best explain the change (a net increase of 2 persons) in the unsheltered count from last year\\'s count are: (1) Change in Implementing the PIT Count, (2) Change in Capacity, (3) and Change in Participation of Partners and Programs.

Change in Implementing the PIT Count: This year volunteers were trained more effectively to ensure de-duplication and successful interview techniques. In addition, the Collaborative Applicant (CA) with PIT Leads conducted weekly meetings to prepare for site based events and coordinate canvassing efforts to ensure a more accurate and complete count. This year, additional canvassing teams were organized to cover additional encampments and a greater area of municipalities and utilized an app that geocode those surveyed. The CoC conducted outreach to the businesses aware of the PIT count and received donations for site based events. The CoC hosted outreach events providing food, warm clothing items, access to showers, laundry, vaccines and other essential items that were well advertised.

Change in Capacity: Change in capacity also impacted a reported increase in persons experiencing unsheltered homelessness. This year over the CoC\\\'s geographic area, there has been a decrease in available units, making it difficult to connect persons experiencing homelessness with housing (even when clients have subsidies in hand). As a result, providers have seen an increase in homelessness.

Change in Participation of Partners & Programs: There was increased interest in participating as a volunteer for the count with most COVID restrictions lifted. The CoC used COVID safety protocols including access to vaccines on the day of the count. Multiple agencies provided staff to assist in coordinating services at outreach events that included food, warm clothing items, access to laundry and showers, haircuts, and vaccines. The CoC was able to host day long outreach events that required increased participation. The CoC engaged local elected officials and law enforcement to assist in canvassing and to join in volunteering in outreach events.
